Cordero AN ORDINANCE PROHIBITING THE CUTTING OF BAMBOO SHOOTS ALONG RIVER BANKS AND PUBLIC LANDS WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR AND IMPOSING PENALTY FOR VIOLATION THEREOF. BE ORDAINED BY THE SANGGUNIANG BAYAN OF NARVACAN, ILOCOS SUR ON SESSION ASSEMBLED. Section 1. The cutting of bamboo shoots along river banks and in any public land as herein provided is strictly banned the territorial jurisdiction of the Municipality of Narvacan. 2. It has been observed that there is dangerous and reckless cutting of bamboo shoots thereby causing the complete, disappearance of bamboo trees along river banks and in public lands. Section 3. Bamboo trees grown or planted along river banks act as river control and are natural protectors of soil erosion. Bamboo shoots cut recklessly leads to the disappearance of bamboo trees which serve as river control and protect soil erosion of streets, public lands as well as private lands. To put an end of this reckless practice of cutting Section 4. bamboo shoots, any person who violates this Ordinance shall be penalized by a fine of One Hundred Pesos (P100.00) and an imprisonment of one (1)week or seven (7) days for the first offense; second offense - a fine of One Thousand Pesos (P1,000.00) but not more than Two Thousand Pesos (P2,000.00) and an imprisonment of five (5) months but not exceeding one (1) year or both as fine and imprisonment at the discretion of honorable court. Section 5. The Municipal Mayor may from time to time issue rules and regulations as he may deem fit and necessary for the effective implementation of this Ordinance. Section 6. This Ordinance shall take effect upon its approval and copies of this Ordinance shall be sent to all Barangay Councils of Narvacan, Ilocos Sur. ENACTED.
