AN ORDINANCE APPROPRIATING TWO HUNDRED THOUSAND PESOS (P200,000.00) OR SO MUCH THEREOF NECESSARY FROM ANY AVAILABLE FUNDS FOR THE ERECTION OF A MEMORIAL MONUMENT GARDEN PARK AT THE CENTER OF NARVACAN-ABRA JUNCTION LOCATED AT BARANGAY QUINARAYAN, NARVACAN, ILOCOS SUR.

Section 1. - This Ordinance shall be known as the MEMORIAL MONUMENT GARDEN PARK OF 1994.

Section 2. - It is a policy of the Municipal Administration to develop and improve cultural heritage and historical sites in the municipality as part of its cultural development and tourism promotion program. The development of these sites therefore will promote their historical values as these will help remind Narvacaneos of their past while encouraging them to scale greater heights in the attainment of a progressive Narvacan.

Section 3. - This Ordinance has two objectives:

- a. It beautifies the place, thereby promoting local tourism; and
- b. Memorial Monument to depict the bravery and heroism of Narvacan soldiers and people that led to the emancipation of the town from the Japanese occupation during the World War II.

Section 4. - Implementing Clause - The Municipal Mayor may issue rules and regulations as he may deem fit and necessary for the effective implementation of this Ordinance.

Section 5. - Effectivity - This Ordinance shall take effect upon its approval.
