AN ORDINANCE REQUIRING ALL STALLHOLDERS AND AMBULANT MARKET VENDORS IN THE NARVACAN PUBLIC MARKET TO PROVIDE FOR THEIR INDIVIDUAL TRASH CAN WITH COVER WHEREIN TO DEPOSIT THEIR WASTE MATERIALS

SECTION 1 - Title

This Ordinance shall be known as MAKE THE NARVACAN NEW PUBLIC MARKET CLEAN, SANITARY AND ATTRACTIVE

SECTION II - Basis

Book III - Title Two - Chapter 3 - Article 3 Section 447 paragraph 4 (ii) of the Local Government Code of 1991 (R.A. 7180)

SECTION III - Basic Objectives

- Administration to create civic-conclousness for the participatory involvement of the people in making a clean, sanitary and attractive environment that will redound to the fullest development of Narvacan as a self-reliant community.
- b. It is likewise the objective of the Municipal Administration to require local government units, non-government and people's organizations and other concerned sectors towards participation in the project implementation of the program to Make Narvacan, Clean, Sanitary and Attractive.

SECTION IV - Provision

Requiring all stall holders and ambulant market vendors operating in the Narvacan New Public Market to provide their own trash cans or plastic bags wherein to deposit their own waste materials.

SECTION V - Penal Provision

Upon failure to comply with said requirements, violators will be penalized a fine of P100.00 for the first offense and cancellation of Mayor's Permit for succeeding offenses.
