AN ORDINANCE REQUIRING THE ESTABLISHMENT OF BARANGAY DRUG  
MONITORING COMMITTEES

WHEREAS, it is the desire of public to ensure the welfare of our youth to be free from the deleterious effects of prohibited drugs and other dangerous substances and the consequent evils such malady produces;

WHEREAS, the participation of the Barangay is deemed an efficient component in governmental efforts to control the sale, use and proliferation of prohibited drugs and other dangerous substances and the prevention of other drug related offenses;


NOW THEREFORE BE IT ORDAINED as it hereby Ordained:

Section 1. Each Barangay of the Municipality of Narvacan, Ilocos Sur shall create a Barangay Drug Monitoring Committee (BDMC) composed of all the members of the Sangguniang Barangay to serve in *ex-officio* capacities.


Section 2. The BDMC shall be responsible for the preparation of action plans towards drug prevention efforts in their respective Barangays, in conjunction and coordination with the appropriate governmental agencies. The BDMC shall submit a written report to the Office of the Mayor and the Sangguniang Bayan concerning the drug problem situation within its area of responsibility on a monthly basis or as the situation warrants with suggested recommendations to address the same for the proper disposition of said offices and of duly constituted authorities.

Section 3. This Ordinance shall take effect immediately upon approval.
