ORDINANCE NO. 98-05 Series of 1998

AN ORDERANCE REGULATING TRAFFIC ON MUNICIPAL STREETS AND BARANGAY ROADS WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

BE IT EN. CTED by the Sangguniang Bayan members in session assembled that:

Section 1. The Sangguniang Bayan under its legislative authority hereby promutate Rules and Regulations for the proper and effective traffic management in the municipality of Narvacan, Ilocos Sur;

Section 2 The temporary closure of streets or roads is authorized during market days (Sundays), Agri-industrial hirs, implementation of public works, projects and other meritorious lawful purposes which promote public welfare provided, adequate alternate facilities/routes are made available for the public;

Section 3- No treet or road will be temporarily closed for purely private uses which are prejudicial to public interest; and welfare;

Section 4 - Tra fic signs will be strategically placed at streets/road sections to guide motorists and the public to effect smooth, orderly flow of traffic to minimize traffic accidente saving lives and properties;

Section 5 -

(a) the following streets are one-way:
From N stional Highway through Bonitacio Street-Daily 6:00 am - 6:00 pm
Rizal Park West Entrance along San Jose St. - Sundays only

(b) Trat fic policemen/aides must show courtesy in dealing with the public.

Section 6 -

(a) Proper parking at designated areas for tricycle, jeepneys, cargo trucks, etc. marked with painted lines must be strictly observed at all times to maximize use of limited space and ease congestion and for faster mobility of vehicles of the travelling public

(b) Double parking is prohibited.

(c) Unicading of commercial goods:

- no un oading of commercial good shall be done from 7 o'clock a.m. onward.

unloa ling of commercial items shall be done from 5:00 a.m. to 7:00 o'clock a.m. only everyday except Sunday.

- Cargo and Commercial truck shall park along Damasco Street.

(d) Tricycles must unload and load passengers only at designated areas.
