AN ORDINANCE ENFORCING CURFEW TO MINORS AS A SAFETY MEASURE TO PROMOTE THEIR WELFARE

BE IT ENACTED by the Sangguniang Bayan in session assembled that:

Sec. 1 - Legal basis - It is a constitutional mandate that the government must promote the welfare of the youth which encompasses the social, cultural educational, economic, moral, spiritual and physical development to mold their character to become responsible citizens;

Sec. 2 - Definition of Terms

 a. curfew is an order or regulation requiring a specific class, to stay off the streets and other public places at specified hours.

b. minors are both young boys and girls whose ages are below eighteen (18) years old which is the minimum legal age under the law.

Sec. 3 - Prohibition - Minors are prohibited to be roaming in the streets, parks, plaza, beaches and other public places from 10 o'clock in the evening to 5 o'clock in the morning of the following day to protect them from child abuse, drug influence and other hazards which are detrimental to their health and safety.

Movement of minors to any of the above-cited places, maybe allowed, provided, they are accompanied by the parents, guardians and other responsible adults who go out for relaxation or attend legitimate wholesome activities.

Sec. 4 - Penalty - Parents or guardians of minors violating this ordinance are meted fines as specified below:

1st offense --- P 100.00 200. 2nd offense --- 200.00 300 3rd offense --- 500.00 500

Sec. 5 - Effectivitythis ordinance shall take effect 30 days after itsapproval.
