> ORDINANCE NO. 98-03 Series of 1998

AN ORDINANCE REQUIRING THE NUMBERING OF ALL TRICYCLES OPERATING AS PUBLIC UTILITY VEHICLES OR NON-PUBLIC UTILITY VEHICLES WITHIN THE MUNICIPALITY OF NARVACAN. ILOCOS SUR

BE IT ENACTED by the Sangguniang Bayan members in session assembled that -

Sec. 1 - Legal basis - the Sangguniang Bayan under its legislative authority pursuant to Sec. 447 RA 7160, hereby regulates, the operation of all tricycles and grant franchises to operate thereat subject to the guidelines prescribed by the DOTC and in compliance to other requirements of the municipal government and to safeguard public welfare;

Sec. 2 - Coverage - all owners/operators of tricycles operating within the jurisdiction of the Municipality of Narvacan, Ilocos Sur must secure stickers bearing the assigned number and affix it at designated area on the unit and pay such amount as may be determined by the Licensing Officer who issues Official Receipt as evidence of payment;

Sec. 3 - Penalty - a tricycle which does not have the required numbers will be impounded and to be redeemed only after the owner/operator has properly complied with this Ordinance and subject to pay a fine of P 300.00;

Sec. 4. Compliance period - All tricycle units must be subjected to comply with the requirements of this ordinance on or before 30 December 1998. Non-complying units will not be granted/renewed their franchises.

Sec. 5 - Effectivity This ordinance takes effect 30 days after its approval.

Sec. 6 - Final Provision - This Ordinance supercedes all previous ordinances which provisions are in conflict with this ordinance.
