AN ORDINANCE TO CONSERVE AND PROTECT, AQUATIC RESOURCES BY REGULATING FISHING WITHIN THE MUNICIPAL WATERS UNDER THE JURISDICTION OF NARVACAN, ILOCOS SUR

BE IT ENACTED by the Sangguniang Bayan members in session assembled:

Section I. Scope- Fishing is hereby regulated within municipal waters, both in the coastal zone fifteen kms. from the shoreline and inland waters (rivers and creeks) aimed to conserve and protect aquatic resources to ensure adequate food supply;

Section II. Prohibition - It is hereby declared unlawful for any person or persons to catch "awa" (breeder of Bangus fry) with the use of "fish-gill net) liteng, or by any other fishing gears;

Section III. - Other illegal fishing methods specified under existing laws banned are dynamite fishing and use of poisonous chemical substances which deplete fish supply, killing all kinds and sizes of fish and to protect the health of the consuming public from eating poisoned fish;


Section IV. - Law enforcers, Barangay Councils and Barangay Tanods are mandated to catch/apprehend violators of this ordinance;


Section V. Penalty - Any person found violating this Ordinance shall be fined P 2,500 or six months imprisonment or both depending on the discretion of the court.

Section VI. - This ordinance supercedes any previous municipal ordinance.


Section VII. Effectivity - Ordinance takes effect immediately.
