ORDINANCE NO. 98-11  
Series of 2000

AN ORDINANCE PROHIBITING SMOKING IN ENCLOSED PUBLIC PLACES/AND PUBLIC CONVEYANCES AS HEREIN SPECIFIED, PROVIDING PENALTY FOR VIOLATION THEREOF

BE IT ENACTED by the Sangguniang Bayan in session assembled that:

Section 1 - Government Warning: Cigarette smoking is dangerous to your health;

Section 2 - Smoking poses a serious health hazard both to smokers and non-smokers who inhale the smoke-polluted air;

a) which is the number 10 cause of mortality among Filipinos, who suffer from chronic obstructive pulmonary diseases due to chemicals produced by burning cigarettes;

b) Smoking during pregnancy causes fetal damage;

c) cigarettes are nicotine addictive - to quit smoking is difficult when hooked.

Section 3 - Prohibition: It is hereby decreed that smoking is prohibited in enclosed public places and in public conveyances as hereunder specified:

a) Public places include: Offices, schools, hospitals, medical clinics, banks, department stores, markets, restaurants, and other places where people converge;

b) Public conveyances: Tricycles, jeepneys, mini-buses, buses and other types of public transport;

Section 4 - Posting "No Smoking Notices". Head of Offices, hospitals, medical clinics, schools, owners/operators of business establishments, public transport are required to post notices in conspicuous places within their establishments/offices, vehicles to inform/warn the public of such prohibition.

Section 5 - Selling cigarettes and other tobacco products to young people, 18 years old and below is prohibited.

Section 6 - Penalty - (Fines and or cancellation of permit/license).

a) Violators:

1st offense - - - - - P 50.00

2nd offense - - - - - 100.00


3rd offense - - - - - 200.00

b) Business establishments will suffer cancellation of their permits/licenses for failure to enforce this Ordinance.


Section 7 - Effectivity: This ordinance shall take effect (30) days after its approval.




