> ORDINANCE NO. 98-14 Series of 2001

AN ORDINANCE PROHIBITING SCHOOL PUPILS AND STUDENTS FROM LOITERING/PLAYING IN VIDEO BARS/BILLIARD HALLS DURING SCHOOL DAYS

BE IT ENACTED by the Sangguniang Bayan in session assembled that:

Section 1. Definition of Terms

Pupils – those who are currently enrolled in the primary and elementary schools
Students – those who are currently enrolled in secondary schools in the municipality
Video Bars – establishments offering computer and video games
Billiard Halls – establishments offering billiard games

Section 2. Purpose

This ordinance aims to instill discipline among students to support family, school and churches' efforts to enhance the moral, spiritual and welfare of the youth to mold them with strong character prepared to be future leaders of the community;

Section 3. Prohibition

- A. School pupils and students are not allowed to enter video bars/ billiard halls during school days.
- B. Video Bar/Billiard Hall operators must deny admission of school pupils and students from entering their amusement centers and shall post at the establishment's entrance the following instruction:

Section 4. Scope

- A. This Ordinance shall only be applicable to pupils/students enrolled in schools within the municipality.
- B. Video Bars/Billiard Hall operators should maintain a policy of no admission for pupils/students who are in school uniform.

Section 5. Penalty

A. It is the discretion of the school management to impose the appropriate penalty for pupils/students caught violating this ordinance.

B. Video Bars/Billiard Halls violating this ordinance shall be meted fines as specified below:

The Local PNP is hereby authorized to implement this ordinance in accordance with existing laws and regulations.

Section 7. Effectivity

This ordinance shall take effect 30 days after its approval.
