AN ORDINANCE WHICH PROHIBITS STRAY DOGS WITHIN THE PREMISES OF THE PUBLIC MARKET TO KEEP AND MAINTAIN SANITATION THEREAT IN THE INTEREST OF PUBLIC HEALTH AND WELFARE

BE IT ENACTED by the Sangguniang Bayan of Narvacan, Ilocos Sur in session assembled that:

- Sec. 1 Purpose The ordinance prohibits stray dogs within the premises of the public market to prevent scavenging and scattering of garbage by dogs to effect faster collection of garbage and maintain sanitation thereat, to promote a healthful environment in the interest of public health and welfare.
- Sec. 2 Dog owners residing in poblacion are required to chain, their dogs or keep their dogs within their enclosed yards as in dog houses, built for the purpose to prevent them from straying.
- Sec. 3 Penalty owners of dogs who through negligence or refusal to comply with this ordinance if and when their dogs are caught within the premises of the market scavenging garbage deposited in garbage receptacle, this scattering garbage, both unsanitary and unsightly, which is detrimental to public health will be imposed a fine as hereunder specified:

P 100.00/dog caught

Sec. 4 -

- a) The Barangay Tanods of San Jose and Sta. Lucia and the municipal utility workers are hereby authorized to implement this ordinance who are entitled to receive an incentive of P 50.00 for each dog caught to be deducted from the fine imposed.
- b) Failure on the part of dog owners to redeem their dogs, six hours after receipt of notice, their dogs/unclaimed dogs will be sold to interested parties by the municipal treasurer or authorized representative. The proceeds will accrue to the municipal treasury as revenue of the municipality.
 - c) Dogs sold must not be utilized as food for eating dog-meat is illegal.

Sec. 5. Impounding House

The Municipal Engineer is hereby directed to supervise the construction of a dog impounding house for this purpose, the construction of which shall be drawn against the general fund of the local government of Narvacan, Ilocos Sur.

Sec. 6 – Effectivity – This ordinance shall take effect 30 days after its approval.
