AN ORDINANCE MANDATING THE SK MUNICIPAL FEDERATION TO UNDERTAKE ACTIVITIES DURING THE "LINGGO NG KABATAAN" IN THE MUNICIPALITY OF NARVACAN PROVIDING FUNDS THEREFORE AND FOR OTHER PURPOSES

Be it ordained by the Sangguniang Bayan of Narvacan, Ilocos Sur that:

Section 1. TITLE OF ORDINANCE: This ordinance shall be known as "AN ORDINANCE MANDATING THE SK MUNICIPAL FEDERATION TO UNDERTAKE ACTIVITIES DURING THE "LINGGO NG KABATAAN" IN THE MUNICIPALITY OF NARVACAN PROVIDING FUNDS THEREFORE AND FOR OTHER PURPOSES."

Section 2. PURPOSE OF ORDINANCE: This ordinance provides for the implementation of Section 439 of R.A. 7160 which pertains to the holding of the "Linggo ng Kabataan".

Section 3. OBSERVANCE OF LINGGO NG KABATAAN: The observance of the "Linggo ng Kabataan" shall be in accordance with the pertinent provisions of R.A. 7160 designating the week within which to observe the "Linggo ng Kabataan". The Municipal Federation of the Sangguniang Kabataan in the Municipality of Narvacan shall hold activities that will promote youth welfare during the "Linggo ng Kabataan".

Section 4. ADMINISTERING BODY: The Pederasyon ng mga Sangguniang Kabataan shall be the lead agency entrusted with the task preparing the program of activities and the conduct of the same all throughout the municipality. Support branches from the municipal government of Narvacan shall assist the Federation in terms of manpower, material and funding support.

Section 5. FUNDING: The Municipal Government of Narvacan, Ilocos Sur shall allocate the amount of One Hundred Thousand Pesos (P100.000.00) in the General Fund Annual Budget of the Municipality for the purpose of holding the "Linggo ng Kabataan" and such fund shall be separate and distinct from the other funds allocated for other youth activities of the municipality.

Section 6. PRIORITY ACTIVITIES:

- a) Holding of a general assembly of all elected Sangguniang Kabataan officials.
- b) Election of counterpart of local government officials and their holding of office for the whole week.
- c) Leadership Training for Student Council Officials.
- d) Anti drug addiction program.

SUPPORT AGENCIES AND INSTRUMENTALITIES: The Office of the Sports Coordinator shall proved manpower requirements for sports and recreation activities. The Municipal Office of Social Welfare and Development (MSWD) and the Municipal Peace and Order Council (MPOC) shall assist in the conduct of Anti-Drug campaign activities; the Municipal Health Office (MHO) shall provide personnel and available first aid kits during activities; and the Municipal Information Office(MIO) shall ensure that there will be sufficient media exposure for the activities during the "Linggo ng Kabataan".

Section 7. REPEALING CLAUSE: All laws and ordinances, rules, regulations and guidelines inconsistent with the provision of this ordinance are hereby repealed.

Section 8. SEPARABILITY CLAUSE: If any section or provision of this ordinance shall be declared unconstitutional, or inoperative by law, those not affected shall remain in full force and effect.

Section 9. EFFECTIVITY: This ordinance shall take effect upon approval.
