AN ORDINANCE IMPOSING AND COLLECTING REGULATORY FEES ON THE OPERATIONS OF PUBLIC UTILITY VEHICLES OR TRANSPORT-FOR-HIRE BUSES BASED IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

BE IT ORDAINED by the Sangguniang Bayan duly assembled that:

Section 1. Definition of Terms

- a. Public Utility/Transport-For-Hire Vehicle – this is a passenger-carrying vehicle with a 40 minimum seating capacity
- b. Regulatory Fee – means a charge for the regulation or inspection of a business or activity

Section 2. Regulatory Fees

The following annual fees shall be collected from operators of public utility vehicles or transport-for-hire buses:

- a. Secretary's Fee P20.00
- b. Garbage Fee P40.00
- c. Bus Fee P400.00/unit for large bus
P300.00/unit for mini bus
- d. Fire Inspection Fee 10% of the total amount of items a,b and c.

Section 3. Incorporation to the Municipal Revenue Code

This ordinance shall form part of the Municipal Revenue Code of Narvacan, Ilocos Sur, hence its incorporation as part of its provisions.

Section 4. Penalty

Failure to pay the fees shall result to a minimum surcharge of 25% of the amount of fees not paid in time, subject however to the assessment of the Business Permits and Licensing Officer of the Local Government Unit.
