AN ORDINANCE AMENDING SECTION 5A-02 OF CHAPTER V OF THE 2000 REVISED MUNICIPAL REVENUE CODE OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

- WHEREAS, Section 5A-02 of Chapter V of the Revised Municipal Revenue Code of Narvacan, Ilocos Sur provides for the schedules of rental fees of different stalls in the Narvacan Public Market;

WHEREAS, the Municipal Administration has not imposed any increase in market rental fees since the new Narvacan Public Market started its operations;

WHEREAS, in view of the increasing overhead cost of maintaining and operating the Narvacan Public Market, there is a need to increase reasonably market rental fees being charged to stall owners;

WHEREAS, in line with this, rates for acquiring new rights to stalls at the Narvacan Public Market are provided herein and shall form part of the provisions of the Municipal Revenue Code, hence its incorporation as such;

NOW THEREFORE, BE IT RESOLVED BY THE SANGGUNIANG BAYAN in session duly assembled to enact this amending ordinance.

Section 1. Section 5A-02 of Section V of the 2000 Revised Municipal Revenue Code of Narvacan, Ilocos Sur is hereby amended to read as follows:

Section 5A-02. Imposition of Fees – There shall be collected the following fees:

A. Rental Fee on Market Stalls

Section 2. Issuance of New Stall Rights and Fees Thereof


An individual or entity may be issued new rights to stalls at the Narvacan Public Market provided that the following "rights" fees shall be paid:

Market Stall	P30,000.00
Ground Vegetable Section	1,000.00
Vegetable Section	2,000.00
Fish Section	3,000.00
Meat Section	5,000.00
Mini Grocery	3,000.00


Section 3. Effectivity. This Ordinance shall take effect immediately upon its approval.
