AN ORDINANCE ESTABLISHING PRINTING SERVICES AND POSTING CHARGES THEREOF BY THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

WHEREAS, the Municipality of Narvacan bought a risograph machine for use in the printing of pertinent papers, documents, files and forms;

WHEREAS, the Municipality of Narvacan thought of an income-generating measure utilizing the said machine in order to recover its cost;

WHEREAS, said income-generating measure is the establishment of printing services whereby this municipality shall sell printed forms at a reasonable price;

WHEREAS, while generating revenues, the Municipality could also help ease the burden of the people from expensive printing services offered by the private printing establishments;

NOW THEREFORE, BE IT ENACTED by the Sangguniang Bayan of Narvacan, Ilocos Sur in a session duly assembled to:

SECTION 1. Establish printing services by the Municipality of Narvacan, Ilocos Sur.

SECTION 2. Post charges on printing services by this municipality, to wit:

- 2.1. Printed form for short ordinary paper shall cost P.70 / piece.
- 2.2. Printed form for long ordinary paper shall cost P.80 / piece.
- 2.3. Printed form for 11" x 17" ordinary paper shall cost P1.20 / piece.
- 2.4. Colored form for short ordinary paper shall cost P20.00 / piece.
- 2.5. Colored form for long ordinary paper shall cost P30.00 / piece.
- 2.6 Colored form for 11" x 17" ordinary paper shall cost P60.00 / piece.

SECTION 3. The minimum volume for printing / reproduction shall be fifty (50) pieces per copy to recover the cost of printing.

SECTION 4. There shall be cost adjustment depending on the size and type of paper to be used in printing.

SECTION 5. Charges shall be paid to the Municipal Treasurer prior to printing.

SECTION 6. This ordinance shall take effect immediately upon approval.


