**AN ORDINANCE IMPOSING AND COLLECTING FEES AND CHARGES FOR SERVICES RENDERED OVER THE OPERATIONS OF ELECTRIC COMPANIES/ CORPORATIONS/ COOPERATIVES IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR.**

**BE IT ENACTED** by the Sangguniang Bayan of Narvacan, Ilocos Sur that:

**SECTION 1.** The Local Government Code of 1991 empowers the Local Government Unit to impose and collect reasonable fees and charges for services rendered through an appropriate ordinance.

**SECTION 2.** There is hereby imposed fees and charges for services rendered over the operations of electric companies/corporations/cooperatives in the municipality of Narvacan, Ilocos Sur, to wit:

Mayor's Permit	P2,000.00
License	.875% on gross sales of electricity
Garbage Fee	P 40.00
Secretary's Fee	P 20.00
Fire clearance	1% of the total above

**SECTION 3.** The fees and charges shall be paid to the Municipal Treasurer on or before the 20<sup>th</sup> day of January or of each subsequent quarter as the case may be.


**SECTION 4.** Failure to pay the fees and charges shall result to surcharges of 25% of the amount of fee not paid in time.

**SECTION 5.** All revenue ordinances inconsistent with this ordinance are hereby repealed or modified accordingly.

**SECTION 6.** This ordinance shall take effect upon approval of the Sangguniang Panlalawigan of the Province of Ilocos Sur.
