**RESOLUTION ALLOCATING FUNDS FOR MUNICIPAL DEVELOPMENT PROJECTS IN THE AMOUNT OF ONE MILLION SEVEN HUNDRED SEVENTY FIVE THOUSAND NINETY SEVEN PESOS ( P 1,775,097.00) REPRESENTING THE DIRECT SHARE OF THE MUNICIPALITY OF NARVACAN FROM THE TOBACCO EXCISE TAX PURSUANT TO RA 7171 FOR THE CALENDAR YEAR 2007**






