## ORDINANCE NO. 06 Series of 2008

AN ORDINANCE AMENDING SECTION 4 OF ORDINANCE NO. 98-04, SERIES OF 1998 ENTITLED AN ORDINANCE ENFORCING CURFEW TO MINORS AS A SAFETY MEASURE TO PROMOTE THEIR WELFARE

**WHEREAS**, the Municipality of Narvacan, Ilocos Sur enacted on September 2, 1998 Ordinance No. 98-04, Series of 1998 otherwise known as An Ordinance Enforcing Curfew To Minors As A Safety Measure To Promote Their Welfare;

**WHEREAS,** Section 4 of Ordinance No. 98-04, Series of 1998 provides for the penalty of parents or guardians of minors violating the said Ordinance;

**WHEREAS**, the Municipal Government of Narvacan deems it very necessary to effect an increase in the penalties so as to ensure strict observance of the Ordinance;

**NOW THEREFORE, BE IT RESOLVED** by the Sangguniang Bayan duly assembled to enact this amending ordinance.

**SECTION 1.** Section 4 of Ordinance No. 98-04, Series of 1998 entitled An Ordinance Enforcing Curfew To Minors As A Safety Measure To Promote Their Welfare is hereby amended as follows:

Section 4. Penalty. Parents or guardians of minors violating this Ordinance are meted fines as specified below:

First Offense	P200.00
Second Offense	P300.00
Third Offense	P500.00

**SECTION 2.** Effectivity. This Ordinance shall take effect 30 days after its approval.
