## AN ORDINANCE REGULATING THE USE OF THE DUPMSITE AT BRGY. TUROD, NARVACAN, ILOCOS SUR

**BE IT ENACTED** by the Sangguniang Bayan of Narvacan, Ilocos Sur in session duly assembled that:

**SECTION 1. Purpose.** This Ordinance aims to regulate the use of the dumpsite at Brgy. Turod, Narvacan, Ilocos Sur to maintain sanitation thereat and to promote a healthful environment in the interest of public health and welfare.

### **SECTION 2. Prohibitions.**

- a. It shall be unlawful for any person to dispose garbage at the dumpsite without proper authorization/permit from the municipal government.
- It shall be unlawful for any person to throw or dispose garbage outside the designated dumping area.

**SECTION 3. Penalty.** Any person found violating Sections a and b of Section 2 shall be meted the following penalties to wit:

a. First offense - P 1,000.00 b. Second offense - P 2,000.00 c. Third & succeeding offenses - P 3,000.00

### **SECTION 4. Final Provisions.**

- a. Repealing Clause. All municipal ordinances, municipal executive orders, administrative regulations, or parts thereof which are inconsistent with any of the provisions of this Ordinance are hereby repealed or amended accordingly.
- b. Separability Clause. If any part or provision of this Ordinance shall be declared unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in force and effect.
- c. Effectivity Clause. This Ordinance shall take effect upon final approval.
