**ORDINANCE NO. 05**

**ORDINANCE GRANTING TEMPORARY CLOSURE OF ROADS AT THE POBLACION AREA IN CONSIDERATION TO THE CELEBRATION OF THE 442<sup>nd</sup> TOWN FIESTA CELEBRATION OF NARVACAN, ILOCOS SUR, THE ANNUAL BAGNET FESTIVAL AND CONTINUING THROUGH THE HOLIDAY SEASON**

Be it ordained by the Sanggunian Bayan in a session assembled that:

**SECTION 1. LEGAL BASIS.** Chapter I, Section 21, Paragraph (a) *of the Local Government Code states that "a local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction", and "(d) Any city, municipality or Barangay may, by a duly enacted close and regulate the use of any local ordinance, temporarily street, road, thoroughfare, or any other public place where shopping malls, Sunday, flea or night markets, or shopping areas may be established and where goods, merchandise, foodstuffs, commodities, or articles of commerce may be sold and dispensed to the general public."*

**SECTION 2. TITLE.** This Ordinance shall be known as "**ORDINANCE GRANTING TEMPORARY CLOSURE OF ROADS AT THE POBLACION AREA IN CONSIDERATION TO THE CELEBRATION OF THE 442<sup>nd</sup> TOWN FIESTA CELEBRATION OF NARVACAN, ILOCOS SUR, THE ANNUAL BAGNET FESTIVAL AND CONTINUING THROUGH THE HOLIDAY SEASON;**

**SECTION 3. PURPOSE:**

- a. For the celebration of LGU Narvacan, Ilocos Sur 442<sup>nd</sup> Town Fiesta/Founding Anniversary commencing on November 11, 2018 with the start of the Sports Festival and its formal opening on December 9 to December 15, 2018;
- b. To pave way for the Summer Bazaar to prosper that public streets of the town proper are being utilized to accommodate the influx of traders, businessmen, vendors, and peddlers who come in big number joining the organized bargain centers to display their products, goods and services;
- c. To utilize the public streets at the town proper during festivities to accommodate the influx of traders, businessmen, vendors and peddlers who come in big number joining the organized trade fairs, bargain centers, carnival rides and to pave way for the Panganan Food Festival 2018;

**SECTION 4. COVERAGE.** To issue temporary closure of some major streets, namely: **a) Republic Street** South of the Public Market (all the way to Narvacan South Central School); **b) Bonifacio Street** North of the Public Market; **c) the Street between Phase I and Phase II** of the Public Market; **d) San Jose Street** (from St. Lucy Parish Church to Bauco st.)

**SECTION 5. DURATION.** The temporary closure shall start on November 11, 2018 and end on January 3, 2019.

**SECTION 6.** The Municipal Mayor shall be given authority to issue the temporary closure order.


**SECTION 7. SEPARABILITY CLAUSE.** If any provision or part thereof is held invalid or unconstitutional, the provision not otherwise affected shall remain valid and subsisting.

**SECTION 8.** Any law, presidential decree or issuance, executive order, rules or regulations contrary to, or inconsistent with the provisions of this Ordinance is hereby repealed, modified or amended accordingly.

**SECTION 9. EFFECTIVITY CLAUSE.** This ordinance shall take effect immediately upon approval and posted in three (3) conspicuous places within the municipality.
