## APPROPRIATION ORDINANCE NO. 04 Series of 2018

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 02, SERIES OF 2018 INVOLVING AN AMOUNT OF ONE MILLION FIVE HUNDRED EIGHT THOUSAND THREE HUNDRED THIRTY THREE PESOS AND THIRTY FOUR CENTAVOS (P 1,508,333.34) FOR THE PURCHASE OF ONE UNIT ELECTRIC GENERATING SET AND AIRCONDITION FOR THE MUNICIPAL HALL OF NARVACAN, ILOCOS SUR

Be it ordained in Regular Session assembled:

**Section 1.** The Supplemental Budget of the Local Government Unit of Narvacan, Ilocos Sur for Fiscal Year 2018 in the amount of One Million Five Hundred Eight Thousand Three Hundred Thirty Three Pesos And Thirty Four Centavos (P 1,508,333.34) For The Purchase Of One Unit Electric Generating Set And Air-condition For The Municipal Hall Of Narvacan, Ilocos Sur is hereby approved.

**Section 2. Sources of Funds.** The sources of funds for the Supplemental Budget in the total amount of One Million Five Hundred Eight Thousand Three Hundred Thirty Three Pesos And Thirty Four Centavos (P 1,508,333.34) shall be as follows:
