ORDINANCE NO. 03 Series of 2018

AN ORDINANCE PROMULGATING THE TEMPORARY CLOSURE OF ROADS AT THE POBLACION AREA FOR THE SUMMER BAZAAR IN PREPARATION OF THE JUNE OPENING OF CLASSES IN NARVACAN, ILOCOS SUR

Be it ordained by the Sanggunian Bayan in a session assembled that:

SECTION 1. TITLE. This Ordinance shall be known as "An Ordinance Promulgating The Temporary Closure Of Roads At The Poblacion Area For The Summer Bazaar In Preparation Of The June Opening Of Classes in Narvacan, Ilocos Sur";

SECTION 2. OBJECTIVE.

- a. To pave way for the Summer Bazaar to prosper that public streets of the town proper are being utilized to accommodate the influx of traders, businessmen, vendors, and peddlers who come in big number joining the organized bargain centers to display their products, goods and services;
- To give the local residents access to bargain for lower prices for the needs of their school children in preparation for the opening of classes.

SECTION 3. LEGAL BASIS. Chapter I, Section 21, Paragraph (a) of the Local Government Code states that "a local government unit may, pursuant to an ordinance, permanently or **temporarily close** or open any local road, alley, park, or square falling within its jurisdiction", and "(d) Any city, municipality or Barangay may, by a duly enacted close and regulate the use of any local ordinance, temporarily street, road, thoroughfare, or any other public place where shopping malls, Sunday, flea or night markets, or shopping areas may be established and where goods, merchandise, foodstuffs, commodities, or articles of commerce may be sold and dispensed to the general public."

SECTION 4. COVERAGE

- Temporary closure shall run from May 23, 2018 to July 23, 2018;
- Temporary closure shall pertain to the following major streets:
 - a) Republic Street South of the Public Market (all the way to Narvacan South Central School);
 - b) Bonifacio Street North of the Public Market;
 - c) the Street between Phase I and Phase II of the Public Market;
 - d) San Jose Street (from St. Lucy Parish Church to Bauco st.)

Be it ordained by the Sanggunian Bayan in a session assembled that:

SECTION 4. COVERAGE

- i. Temporary closure shall run from May 23, 2018 to July 23, 2018;
- ii. Temporary closure shall pertain to the following major streets:
 - a) Republic Street South of the Public Market (all the way to Narvacan South Central School);
 - b) Bonifacio Street North of the Public Market;
 - c) the Street between Phase I and Phase II of the Public Market;
 - d) San Jose Street (from St. Lucy Parish Church to Bauco st.)

SECTION 5. The Municipal Mayor shall be given authority to issue the temporary closure order.

SECTION 6. SEPARABILITY CLAUSE. If any provision or part thereof is held invalid or unconstitutional, the provision not otherwise affected shall remain valid and subsisting.

SECTION 7. Any law, presidential decree or issuance, executive order, rules or regulations contrary to, or inconsistent with the provisions of this Ordinance is hereby repealed, modified or amended accordingly.

SECTION 8. EFFECTIVITY CLAUSE. This ordinance shall take effect immediately upon approval and posted in three (3) conspicuous places within the municipality.

APPROVED UNANIMOUSLY.

I HEREBY CERTIFY to the correctness of the foregoing ordinance.

SECTION 5. The Municipal Mayor shall be given authority to issue the temporary closure order.

SECTION 6. SEPARABILITY CLAUSE. If any provision or part thereof is held invalid or unconstitutional, the provision not otherwise affected shall remain valid and subsisting.

SECTION 7. Any law, presidential decree or issuance, executive order, rules or regulations contrary to, or inconsistent with the provisions of this Ordinance is hereby repealed, modified or amended accordingly.

SECTION 8. EFFECTIVITY CLAUSE. This ordinance shall take effect immediately upon approval and posted in three (3) conspicuous places within the municipality.
