ORDINANCE GRANTING TEMPORARY CLOSURE OF ROADS AT THE POBLACION AREA IN CONSIDERATION TO THE CELEBRATION OF THE 441ST TOWN FIESTA CELEBRATION OF NARVACAN, ILOCOS SUR, THE ANNUAL BAGNET FESTIVAL AND CONTINUING THROUGH THE HOLIDAY SEASON

WHEREAS, Chapter I, Section 21, Paragraph (a) of the Local Government Code states that "a local government unit may, pursuant to an ordinance, permanently or *temporarily close* or open any local road, alley, park, or square falling within its jurisdiction", and Paragraph (c) further states that "Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or *fiesta celebrations*, public rallies, agricultural and industrial affairs, or/and undertaking of public works and highways, telecommunications, and waterworks projects, the duration of which shall be specified by the local chief executive concerned in a written order";
