**AN ORDINANCE PRESCRIBING FEES AND CHARGES FOR THE SERVICES OFFERED IN THE NARVACAN MUNICIPAL HEALTH OFFICE CLINICAL LABORATORY**

**WHEREAS**, the Sangguniang Bayan, through Resolution No. 48, S. 2012 created the Municipal Health Office Clinical Laboratory;

**WHEREAS**, various services are offered in the Municipal Health Laboratory and it is but proper to prescribe reasonable fees and charges to recover the cost of re-agents and laboratory materials;

**NOW THEREFORE, BE IT ENACTED** by the Sangguniang Bayan of Narvacan that:

**SECTION 1.** There is hereby prescribed fees and charges for the services offered in the Narvacan Municipal Health Office Clinical Laboratory.


