ORDINANCE NO. 3
Series of 2012

AN ORDINANCE AUTHORIZING THE REGISTRATION OF ALL INTERESTED LEGITIMATE RESIDENTS AND STUDENTS OF THE BARANGAY AS MEMBER IN THE ELIBRARY OF THE MUNICIPALITY OF NARVACAN AND THE COLLECTION OF MEMBERSHIP FEE AND OTHER CHARGES THEREOF.

Be it ordained by the Sangguniang Bayan of the Municipality of Narvacan in session assembled that:

SECTION 1. PURPOSE. The objective is to maximize access to many users specifically to the students of the Municipality of Narvacan who want to use these resources and fulfill its mission of providing free and equal access to information, knowledge, and independent learning to our constituents. There is hereby established a system of registration and identification of interested residents throughout the Municipality of Narvacan for the following purposes;

- a) To enhance municipal and barangay security and unmask potential terrorists;
- b) To provide a complete and systematic list of old and new residents including transients in all barangays throughout the Municipality for quick reference and identification;
- c) To provide information and data for planning and statistical studies especially as reference for policy formulation;
- d) To formulate a highly efficient system of keeping records of residents in all the barangays in the Municipality of Narvacan;
- e) To efficiently monitor population dispersal and distribution in a particular area that may be used for planning purposes;
- f) To be a reference in updating the Local Civil Registry Records;
- g) To establish an official identification card that will be used by the law enforcement and peacekeeping officers to identify residents;
- h) Be honored by the Municipal government and all barangay governments throughout the Municipality of Narvacan in all transactions that may be entered into by the ID card holder;
- i) To serve such other functions/purposes as may be authorized by law, executive circular, or ordinance of the Municipality;

SECTION 2. DEFINITION OF TERMS: For the purpose of this Ordinance, the following terms shall mean:

Section 2.1. "RESIDENT" refers to its actual resident of the barangay for at least six (6) months at the time of the passage of this Ordinance.

Section 2.2. "TRANSIENT" refers to any person who stays temporarily within a barangay of this Municipality without any intention of residing therein permanently.

Section 2.3. "NEWLY-MOVED RESIDENT" refers to a person who has transferred to the barangay for the purpose of residing therein, whether permanently or temporarily such as those who may be transferred to temporary or emergency relocation sites.

Section 2.4. "STUDENT" refers to a person who is presently enrolled to any public or private school within the Municipality of Narvacan.

Section 2.5. "ESTABLISHMENT OF RESIDENCY" shall refer to the period that a person actually moves/transfers to or stays in a particular barangay with the intention to establish his residence therein.

SECTION 3. COVERAGE. All individuals, regardless of age and nature of residency whether as homeowner, lessee, transient, and stay-in domestic helper, residing in the barangays within the Municipality of Narvacan together and all persons duly registered students within the barangay shall be covered by this ordinance.

SECTION 4. FEES. All newly transferred/moved residents and transients within a particular barangay within the Municipality of Narvacan and students of the public and private schools within the Municipality of Narvacan shall be required to accomplish the required application form if they desire to be a member of the eLibrary and shall pay the required fees as necessary:

- a) Membership fee of Php150.00
- b) Printing
 - 1) Printing is available for black and white Php3.00 per page (8.5 x 11 paper size) and Php3.50 per page (8.5 x 14 paper size)
 - 2) For color text print Php3.50 per page (8.5 x 11 paper size) and Php4.00 per page (8.5 x 14 paper size)
 - 3) And for color graphic or pictures printing is also available for Php4.50 per page at 8.5 x 11 paper size and Php5.00 per page for 8.5 x 14 paper size.

In case of loss before the expiry of the ID card, the member residents/students are hereby required to get replacement of the lost ID the same cost of the new card.

SECTION 5. RENEWAL. The Membership Card for the residents and students shall have duration of twelve (12) months, renewable thereafter each year and upon payment of the fees provided in Section 4 herein.

If any barangay residents or students failed to renew on the specified date as provided by this Ordinance, the privileges and benefits as a member is deemed void.

Activation of membership will apply after the payment of the required fee as provided by this Ordinance under Section 4.

SECTION 6. FUNDING REQUIREMENT. For the purpose of this Ordinance, the funding requirement as may be necessary shall be chargeable against savings or any available budgetary appropriation on general fund and shall be appropriated annually for maintenance of the equipments, manpower, and consumables until such time that it can operate based on its own income.

SECTION 7. INCOME BASED ON FEES. All income shall accrue to the general fund of the municipality and can be withdrawn anytime if deemed necessary for the improvement, maintenance, manpower, and consumable for the operation of the eLibrary.

SECTION 8. REPEALING CLAUSE. All ordinances inconsistent with the provisions of this Ordinance are hereby deemed repealed or modified accordingly.

SECTION 9. SEPARABILITY CLAUSE. If any provision/s of this Ordinance be declared unconstitutional or inconsistent with the provisions of any law, the remaining provisions shall remain valid and effective.

SECTION 10. EFFECTIVITY. This Ordinance shall take effect upon approval by the Sangguniang Bayan.




