IV. Reading, consideration, and adoption of the minutes of the previous session

On motion of SBM Cabreros, seconded by SBM Cachola, the reading of the minutes of the 17th regular session was dispensed with. The PO declared the reading of the minutes of the previous session dispensed with.

Having no questions from the members of the SB about the minutes of the 17th regular session, SBM Potencion moved for its adoption and approval which was duly seconded by SBM Cabreros. The PO then declared the minutes of the 17th Regular Session approved and adopted.

No member of the SB stood up for the privilege hour.

SBM Zaragoza made a follow up on his request to invite Mr. Conrado Molina, Municipal Agriculture Officer, to appear before the SB. The PO replied that the Mayor has no response yet.

IX. Calendar of Business

A. Business for the day:

1. As urgent, final reading and approval of:

a. Resolution No. 17, S. 2018 – Resolution Approving the Purchase of Four (4) Units DRR Rescue Vehicles in the Amount of Five Million Two Hundred Fifty Thousand One Hundred Seventy Four (P 5,250,174.00) Funding of Which Came from the Local Government Support Fund- Assistance to Municipalities, DILG-BUB

The PO called for the Municipal Budget Officer to present the specifications and costs (12% VAT inclusive) of the vehicles, to wit:

1. Toyota Hilux 2.4 G DSL 4x2	-	P 1,331,000.00
2. Toyota Hilux 2.8 G DSL 4 x 4	-	P 1,570,000.00
3. Toyota HiAce Commuter 3.0 L	-	P 1,438,000.00
4. Mitsubishi L300 Deluxe Cab 2018	-	694,400.00

The total cost of the 4 vehicles is P 5,033,400. The remaining amount of P 217,174.00 shall be used to set up said automobiles as rescue vehicles.

The PO informed the Body that the DILG and DBM have approved the purchase of the specified vehicles.

SBM Tejada suggested making a clarification whether the Mitsubishi, with its low price of 694,400.00 is as a whole or the body-down type. The Budget Officer agreed to do so.

SBM Dela Cuadra suggested purchasing 4x2E instead of 4x2. Accordingly, there is a slight difference in their prices; the 4x2E is cheaper but works well as the 4x2.

SBM Zaragoza asked if the funds for the said vehicles are now ready. The Budget Officer responded affirmatively. She appended that once the Resolution is signed, they will submit it to the DILG Regional Office for approval of the budget after which the bidding process will follow.
