AN ORDINANCE REQUIRING ALL FOOD OUTLETS OWNERS TO ENSURE SANITATION ON ALL THEIR PRODUCTS FOR SALE AND ON DISPLAY AND PRESCRIBING FINES/PENALTY IN VIOLATION THEREOF

Be it ordained by the Sangguniang Bayan of Narvacan duly assembled.

Section 1. TITLE - This Ordinance shall be known as **AN ORDINANCE REQUIRING ALL FOOD OUTLETS OWNERS TO ASSURE SANITATION ON ALL THEIR PRODUCTS FOR SALE AND ON DISPLAY BY PLACING A PROTECTIVE COVERING AND PRESCRIBING FINES/PENALTY IN VIOLATION THEREOF**

Section 2. Declaration of Policy

It is the policy of the local government unit of Narvacan to guarantee the welfare of the populace by preventing diseases generated through food contamination.

Section 3. Definition of Terms – As used in this Ordinance, the following terms shall mean:

- a. Food outlets – shall include restaurants, eateries, carinderias, snacks houses, burger and bakeries, barbecue stands, ambulant food stalls, and other similar facilities
- b. Sanitation – means of promoting health through maintenance of cleanliness to prevent the proliferation of diseases caused by contamination
- c. Cover – protective covering like stainless, glass, plastic, or paper

Section 4. To prevent the contamination of food products sold in all food outlets, owners or operators of these facilities shall ensure that all their products shall have protective covering and be placed in a glass or plastic enclosures, cabinets or in containers.

Section 5. Food stall owners shall ensure maintenance of cleanliness and proper sanitation in their work areas and require all their cooks, food servers, waiters and waitresses to wear gears such as hairnet, apron, and disposable hand gloves while on duty.

Section 6. Food Stall owners shall ensure proper food handling preparation and encourage food handlers to undergo seminar/workshops sponsored by the Department of Health (DOH).

Section 7. Business permits/licenses shall be renewed only upon certification of the Municipal Sanitary Inspector, who shall every now and then personally inspect the business establishments of their full compliance of this ordinance.

Section 8. Penalty/fines – Violators of this Ordinance shall be reprimanded by the Sanitary Inspector and shall be meted fines as follows:



Section 9. Repealing Clause – All municipal ordinances, resolutions, executive orders, administrative regulations or parts thereof which are inconsistent to any of the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 10. Effectivity – This Ordinance shall take effect fifteen (15) days after its approval by the Sangguniang Bayan of Narvacan.






