### ORDINANCE NO. 02 Series of 2014

ORDINANCE GRANTING SPECIAL PRIVILEGES TO THE SENIOR CITIZENS, PERSONS WITH DISABILITIES AND PREGNANT WOMEN WITH PATHOLOGICAL CONDITIONS OF NARVACAN, ILOCOS SUR IN THE AVAILMENT OF ULTRASOUND SERVICES OFFERED IN THE NARVACAN MUNICIPAL HEALTH OFFICE CLINICAL LABORATORY

**BE IT ENACTED** by the Sangguniang Bayan of Narvacan that:

**SECTION 1.** There is hereby granted special privileges to the senior citizens, persons with disabilities and pregnant women of Narvacan, Ilocos Sur in the availment of ultrasound services offered in the Narvacan Municipal Health Office Clinical Laboratory.

**SECTION 2.** The senior citizens, persons with disabilities and pregnant women with pathological conditions with the necessary doctor's orders can avail of the ultrasound services free of charge from the Municipal Health Office Clinical Laboratory.

**SECTION 3.** The ultrasound services shall be priced at flat rates exclusive of the reading fee as follows:

Single organ - P 150.00

Multiple organs - P 400.00

Single organ requiring special procedure - P 400.00

**SECTION 4.** Fees and charges are subject to change depending on the cost of laboratory materials.

**SECTION 5.** This Ordinance shall take effect immediately upon approval.

#### RESOLUTION NO. <u>170-Q XIV</u> Series of 2014

A RESOLUTION APPROVING ORDINANCE NO. 02, SERIES OF 2014, OF NARVACAN, ILOCOS SUR

WHEREAS, Section 468(1)(i) of the Republic Act 7160 otherwise known as the Local Government Code of 1991 provides that the Sangguniang Panlalawigan has the power to review all ordinances approved by the sanggunians of component cities and municipalities;

WHEREAS, Section 56(c) of the same Act provides that If the sangguniang panlalawigan finds that such an ordinance or resolution is beyond the power conferred upon the sangguniang panlungsod or sangguniang bayan concerned, it shall declare such ordinance or resolution invalid in whole or in part;

WHEREAS, the Ordinance No. 02, Series of 2014, of Narvacan, Ilocos Sur granting special privileges to the senior citizens, persons with disabilities and pregnant women with pathological conditions of Narvacan, Ilocos Sur in the availment of ultrasound services offered in the Narvacan Municipal Health Office Clinical Laboratory is not contrary to any existing law, rules and regulations and as well as within the power, duties and functions of the LGU to enact the same, to wit:

**NOW THEREFORE**, the Sangguniang Panlalawigan of Ilocos Sur, in session assembled, on motion of Hon. Pablito F. Sanidad, Jr., duly seconded by Hon. Ismael R. Baterina, **RESOLVED** as it is **HEREBY RESOLVED** to approve the Ordinance No. 02, Series of 2014, of Sta. Catalina, Ilocos Sur.
