## **ORDINANCE NO. 7**

## AN ORDINANCE AMENDING RULE II, SECTION 4, PARAGRAPH 2, OF THE ADOPTED INTERNAL RULES AND PROCEDURES (IRP) FOR THE SANGGUNIANG BAYAN OF NARVACAN, ILOCOS SUR

**WHEREAS,** in the maintenance of good order in sanggunian deliberation, it is necessary that special rules be adopted and enforced in the interest of effective legislation;

**WHEREAS**, Rule II, Section 4, Paragraph 2, which states "In case of designation, as Acting Municipal Mayor or inability or absence of the Regular Vice Mayor, as Presiding Officer, the Sangguniang Bayan Members present constituting a quorum, elect from among themselves a Temporary Acting Presiding Officer. The Acting Presiding Officer shall not vote even in the case of a tie but shall certify within ten (10) days from their enactment or adoption of all Ordinances and Resolutions passed by the Council" is hereby amended;

Now, therefore, **BE IT ORDAINED BY THE** Sangguniang Bayan of the Municipality of Narvacan, Ilocos Sur, that:

- **Section 1.** Rule II, Section 4, Paragraph 2, is hereby amended and shall now be stated: "In case of the inability or absence of the Regular Vice Mayor, as Presiding Officer, there shall be designated a Permanent Acting Presiding Officer or Protempore Sanggunian. The Permanent Acting Presiding Officer shall not vote even in the case of a tie but shall certify within ten (10) days from their enactment or adoption of all Ordinances and Resolutions passed by the Council."
- **Section 2.** This Permanent Acting Presiding Officer shall be designated by a majority of the present elective and appointive members of the Sanggunian through votation.
- **Section 3.** In the event that the Vice Mayor/Permanent Acting Presiding Officer and Protempore Sanggunian are absent, the majority of the present elective and appointive members of the Sanggunian shall designate a Temporary Acting Presiding Officer through votation.
- **Section 4.** The elected Permanent Acting Presiding Officer shall still be the chairman of the various standing committees he is assigned to as usual prior to this amendment.

Rule XIII – EFFECTIVITY – This Rule II, Section 4, Paragraph 2 as amended shall take effect on the date of its adoption .
