AN ORDINANCE AMENDING FURTHER SECTION 3, OF ORDINANCE NO. 5, S. 2013, AS AMENDED, MUNICIPAL ORDINANCE "PROHIBITING THE LITTERING OF ANY WASTE MATERIALS IN PUBLIC PLACES"

WHEREAS, Sec. 3 of Ordinance No. 5, S. 2013, pertains to the creation of an Anti-Littering Task Force to apprehend and report violators;

WHEREAS, the above stated Section 3 deputizes the Traffic Aides, Utility Personnel, Tanods, Market Inspectors and Market Collectors to apprehend and report violators;

WHEREAS, the Sangguniang Bayan deems that it would be more expedient if the Municipal Mayor was given considerable discretion in the selection and appointment of members of the Anti-Littering Task Force through an Executive Order for such purpose;

WHEREAS, the penalty imposed under Section 11 needs to be modified to signify the intent of the law to punish wrongdoers;

NOW THEREFORE, be it ordained by the Sangguniang Bayan of the Municipality of Narvacan, Ilocos Sur, that:

SECTION 1. Section 3 of the Anti-Littering Ordinance, as amended, is hereby further amended to read as follows:

"SECTION 3. CREATION OF ANTI-LITTERING TASK FORCE TO APPREHEND VIOLATORS OF THIS ORDINANCE. An Anti-Littering Task Force shall be created through an Executive Order to be issued by the Municipal Mayor. The Anti-Littering Task Force shall apprehend and report violators of the Municipal Anti-Littering Ordinance, and shall be tasked with the enforcement and implementation of said ordinance and Solid Waste Management laws.

Members of the Anti-Littering Task Force are deputized to apprehend and report violators to the Anti-Littering Desk for the collection of penalties and issuance of Official Receipt. There shall be designated members of the Anti-Littering Task Force who are authorized to issue Citation Tickets. The deputized apprehenders shall be assigned their respective posts during the day with their uniforms and IDs as apprehenders."

SECTION 2. Section 11 of the Anti-Littering Ordinance, as amended, is hereby further amended to read as follows:

"SECTION 11. PENAL CLAUSE. Any violator of this Ordinance shall be fined as follows:

- First Offense - P300.00 or one day community service**
- Second Offense - 500.00 or 3 days community service**
- Third Offense - 1,000.00 and 5 days community service**

SECTION 3. SEPARABILITY CLAUSE

Should any provision, section or part of this ordinance be declared invalid by any court of competent jurisdiction, such judgment shall not affect or impair the remaining provisions, sections or parts hereof which shall continue to be in full force and effect.

SECTION 4. REPEALING CLAUSE


All ordinances, rules and regulation or any part thereof found in conflict or inconsistent with any provision of this ordinance are hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY

This ordinance shall take effect upon approval and posting in 3 conspicuous public places.






