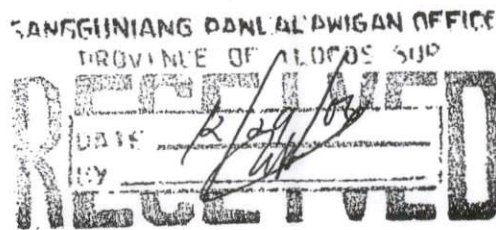

Ordinance No. 08  
Series of 2006

AN ORDINANCE ABOLISHING EIGHT (8) POSITIONS IN THE LOCAL GOVERNMENT UNIT OF NARVACAN, ILOCOS SUR.

BE IT ENACTED by the Sangguniang Bayan of the Municipality of Narvacan, in session assembled:

SECTION 1. It is the policy of the Municipality to determine positions and salaries for the proper conduct of programs, projects, services and activities of the Municipal Government.

SECTION 2. For the judicious improvement of services of the people, eight (8) unfunded positions be abolished as follows:

- a. MARKET INSPECTOR I with salary grade 6, item No. 22 under the Market Enterprise Dev't. and Mgt. effective December 31, 2006;
- b. SOCIAL WELFARE AIDE with salary grade 4, item No. 29 under the Office of the DSWD effective December 31, 2006;
- c. DRAFTSMAN I with salary grade 6, item No. 46 under the Office of the MPDC effective December 31, 2006;
- d. ADMINISTRATIVE ASST. II (Clerk IV) with salary grade 8, item No. 49 under the Office of the LCR effective December 31, 2006;
- e. REVENUE COLLECTION CLERK I with salary grade 5, item No. 71 under the Office of the Mun. Treasurer effective December 31, 2006;
- f. AGRICULTURAL TECHNOLOGIST with salary grade 10, item No. 79 under the Office of the Mun. Agriculturist effective December 31, 2006;





Series of 2006

An Ordinance creating New Four (4) Positions in the Local Government Unit of Narvacan, Ilocos Sur;


Be enacted by the Sangguniang Bayan of the Municipality of Narvacan, Ilocos Sur in session assembled;

SECTION I. It is the policy of the Municipality to determine the positions and salaries for the proper conduct of programs, projects, services and activities of the Municipal Government;

SECTION 2. For the judicious improvement of services to the people, the new four(4) positions be created as follows:

- a. MUNICIPAL ADMINISTRATOR with Salary Grade 24, Item No. 18 under a new and separate office be created effective January 1, 2007;
- b. LICENSING OFFICER IV with Salary Grade 22, Item No.19 under the Office of the Market Enterprises Dev't. and Mgt. be created effective January 1, 2007;
- c. SERVICES OFFICER III with Salary Grade 18, Item No.17 under the Office of the Municipal Mayor be created effective January 1, 2007;
- d. ADMINISTRATIVE ASSISTANT VI (Computer Operator III) with Salary Grade 12, Item No. 16 under the Office of the Mayor be created effective January 1, 2007;

SECTION 3. That the Ordinance shall take effect on the date abovementioned.
