**AN ORDINANCE DESIGNATING THE RIZAL PARK OTHERWISE KNOWN AS "KIOSKO"
AS THE FREEDOM PARK OF THE MUNICIPALITY OF NARVACAN, ILOCOS SUR**

BE IT ENACTED by the Sangguniang Bayan of Narvacan, Ilocos Sur in session duly assembled that:

SECTION 1. Title. This Ordinance shall be known as "The Ordinance on the Designation of Freedom Park".

SECTION 2. Designated Freedom Park. The Rizal Park otherwise known as "Kiosko" shall be the designated Freedom Park of this municipality.

SECTION 3. Objective and Purpose. This Ordinance is enacted for the purpose of establishing a venue for the conduct of public assemblies as defined in Batas Pambansa Blg. 800 and setting the guidelines to be followed.

SECTION 4. Guidelines. The following shall be the guidelines in the use of the Freedom Park:

- a. Public assemblies conducted in the Freedom Park shall be exempted from the requirement of a prior permit for the use from the Office of the Mayor. However, as per Supreme Court pronouncement, organizer/s of assemblies shall send notices to the Municipal Mayor and to the Chief of Police at least three (3) days before the conduct of the activity to allow proper coordination and ensure orderly activities;
- b. A Mayor's permit shall be duly secured pursuant to BP Blg.800 for all public assemblies, such as rally, demonstration, march, parade, procession or any other form of mass or concerted action where public streets are to be utilized;
- c. Pursuant to the power of operational control conferred unto Municipal Mayors over local police stations, all Municipal Mayors are enjoined to advise their respective chief of police that, as part of maximum tolerance, rallyists may show to the Philippine National Police an application duly filed on a given date and can, after two (2) days from said date, rally in accordance with the application without the need to show a permit, the grant of the permit being then presumed under the law, and it shall be the burden of the local authorities to show, that there has been a denial of the application, in which case, the rally may be peacefully dispersed following the procedure of maximum tolerance prescribed by law; and
- d. The organizer/s shall be responsible in the repair / replacement of all damaged structures / fixtures incurred during the conduct of the activity and in cleaning the area of all waste / garbage / debris / rubbish a day right after the activity.

SECTION 5. Effectivity. This Ordinance shall be enforced within the territorial jurisdiction of the municipality of Narvacan, Ilocos Sur fifteen (15) days after its approval.






