AN ORDINANCE AMENDING SECTION 5 OF ORDINANCE NO. 01-05, S. 2002 AN ORDINANCE IMPOSING AND COLLECTING FEES AND CHARGES FOR SERVICES RENDERED OVER THE OPERATIONS OF NETWORK CELLSITE TOWERS WITHIN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR

WHEREAS, Ordinance No. 01-05, Series of 2002 provides for the imposition and collection of fees and charges for services rendered over the operations of network cellsite towers within the municipality of Narvacan, Ilocos Sur;

WHEREAS, Section 5 of Ordinance No. 01-05, S. 2002 imposes that failure of the network cellsite operators to pay the amount of fee in time shall result to surcharges of 25%;

WHEREAS, there is an imperative need to increase the amount of surcharges to curtail delinquency in renewing business permits;

NOW THEREFORE, BE IT RESOLVED BY THE SANGGUNIANG BAYAN in session duly assembled to enact this amending ordinance.

SECTION 1. Section 5 of Ordinance No. 01-05, S. 2002 is hereby amended to read as follows:

Section 5. Failure to pay the fees shall result to surcharges of 25% of the amount of fee not paid in time, plus 2% per month from the date it is due until it is fully paid.

SECTION 2. Effectivity. This Ordinance shall take effect immediately upon its approval.




