APPROPRIATION ORDINANCE NO. 01, SERIES OF 2019 - AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 01, SERIES OF 2019 INVOLVING AN AMOUNT OF THREE MILLION FOUR HUNDRED FORTY NINE THOUSAND PESOS (P 3,449,000.00) FOR PAYMENT OF SEPARATION PAY/TERMINAL PAY OF MUNICIPAL VICE MAYOR, SB MEMBERS, MUNICIPAL ENGINEER AND COTERMINUS MUNICIPAL MAYOR EMPLOYEES AND ADDITIONAL CLOTHING ALLOWANCE OF THE MUNICIPAL OFFICIALS AND EMPLOYEES OF THE MUNICIPALITY OF NARVACAN

Be it ordained in Regular Session assembled:

Section 1. The Supplemental Budget of the Local Government Unit of Narvacan, Ilocos Sur for Fiscal Year 2019 in the amount of Three Million Four Hundred Forty Nine Thousand Pesos (P 3,449,000.00) For Payment Of Separation Pay/Terminal Pay Of Municipal Vice Mayor, SB Members, Municipal Engineer and Co-Terminus Municipal Mayor Employees and Additional Clothing Allowance of the Municipal Officials and Employees of the Municipality Of Narvacan
