**ORDINANCE NO. 01- SS**  
Series of 2019

**ORDINANCE REOPENING OF STA. LUCIA ROAD ADJACENT TO THE MUNICIPAL PLAZA AND THE REMOVAL OF THE STRUCTURE OBSTRUCTING THE SAME**

**WHEREAS**, the Sta. Lucia Road used to be a road and thoroughfare open to both vehicular and pedestrian traffic;

**WHEREAS**, the same was closed due to the construction of a monument/fountain;

**WHEREAS**, the said structure now constitutes not only an eyesore, but obstructs the free flow of the ever growing and increasing vehicular and pedestrian traffic in one of the streets found in and vital to the government and business center of the town;

**WHEREAS**, the Sangguniang Bayan is expressly mandated by the Local Government Code to regulate the use of streets, avenues, alleys, etc. and to approve the construction and improvement and maintenance of the same;

**NOW, THEREFORE, BE IT ORDAINED** by the Sangguniang Bayan of Narvacan in session assembled that;

**SECTION 1. TITLE** - This Ordinance shall be known as "**ORDINANCE REOPENING OF STA. LUCIA ROAD ADJACENT TO THE MUNICIPAL PLAZA AND THE REMOVAL OF THE STRUCTURE OBSTRUCTING THE SAME**";

**SECTION 2. LEGAL BASIS** - Chapter I, Section 21, Paragraph (a) of the Local Government Code states that "*a local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction*";

Ordinance No. 01—SS, Series of 2019.....

**Section 3. SCOPE AND COVERAGE :**

- a. The Sta. Lucia Street is located on the eastern side of the Narvacan Municipal Building traversing the Narvacan Public Market
- b. The construction of a fountain/monument closing the street/road caused the obstruction of the free flow of traffic going to the public market
- c. That the fountain/monument has been neglected, unsafe, unsanitary and an eyesore, hence, no longer serve the purpose for which it was constructed in the first place
- d. That the opening of this road/thoroughfare will hasten the free flow of traffic, vehicular and pedestrian alike
- e. The Municipal Engineer is directed to remove and demolish the said monument/fountain presently existing and obstructing the Sta. Lucia Street and restore the same as a street or road.

**SECTION 4. LIMITATIONS** – The removal of the obstruction and reopening of the Sta. Lucia Street is subject to the following conditions:

- a. The whole length of the Sta. Lucia Street from the market Intersection on the one end and the intersection of the road behind the municipal building on the other end shall be a NO PARKING ZONE for any kind of motor or animal drawn vehicles, including but not limited to motorcycles, tricycles, etc;
- b. NO VENDORS shall be allowed to use, peddle or sell their goods therein and to install signages announcing the same.

**SECTION 5. PENAL PROVISIONS** - Non-compliance with the provisions of this Ordinance shall be dealt with in accordance with pertinent laws, rules and regulations.

**SECTION 6. SEPARABILITY CLAUSE** - Whenever for any reason, any provisions, section or part of this ordinance is declared not valid by a Court of competent jurisdiction or suspended or revoked by the authorities concerned, such judgment shall not affect or impair the remaining provisions or sections which shall continue to be in full force and effect.

**SECTION 7. EFFECTIVITY** - This ordinance shall take effect immediately upon approval.
