**ORDINANCE NO. 23**

Series of 2020

**AN ORDINANCE EXTENDING THE DEADLINE FOR THE PAYMENT OF REAL PROPERTY TAX (RPT) FROM MARCH 31, 2020 TO MAY 31, 2020 WITHOUT INTEREST AND SURCHARGES**

**WHEREAS**, Section 167 of Republic Act 7160, the Local Government Code provides that the Sanggunian, for a justifiable reason or cause, may extend the time of payment of such taxes, fees or charges without penalties, surcharges and interest, but only for a period not exceeding six (6) months;

**WHEREAS**, Presidential Proclamation No. 922, Series 2020, dated March 8, 2020 declared the entire country under a State of Public Health Emergency;

**WHEREAS**, Presidential Proclamation No. 929, Series of 2020, dated March 16, 2020 placed the entire country under a State of Calamity for a period of six (6) months;

**WHEREAS**, on March 15, 2020, the Honorable Governor of the Province of Ilocos Sur, issued Executive Order No. 14, placing the entire Province of Ilocos Sur, under Community Quarantine;

**WHEREAS**, the town of Narvacan is currently under a State of Enhanced Community Quarantine prohibiting residents from going out of their homes and suspending regular government transactions due to the COVID-19 Pandemic;

**NOW THEREFORE, BE IT ORDAINED** by the Sanggunian Bayan, that:

**SECTION 1. Coverage** – The period of payment of all 1<sup>st</sup> Quarter Real Property Tax (RPT) to the Municipality of Narvacan, which should have been due on or before March 31, 2020, is hereby extended, and the same can be paid not later than May 31, 2020, without penalties, surcharges or interest;

Ordinance No. 23, Series of 2020...

**SECTION 2. Penalties, Surcharge and Interests.** All Real Property Tax (RPT) due for the said period shall however be subject to the penalties and interest prescribed under the Revenue Code if payment is made after May 31, 2020;

**SECTION 3. Effectivity** – Due to the present medical emergency and the situation of the entire country and upon motion duly approved suspending the rules of the 3-day reading for the passage of an Ordinance, this Ordinance shall take effect immediately upon its approval.

Let copies of this Ordinance be posted in prominent places in the municipal hall and publication be made when conditions will warrant.
