**AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE NO. 19, SERIES OF 2020 IMPOSING WEARING OF MASK OR ANY PROTECTIVE COVERING IN SUBSTITUTE OF MASK AND CURFEW TO PREVENT FURTHER INFECTIONS OF THE NOVEL CORONA VIRUS DISEASE (COVID 19)**

**WHEREAS**, on March 11, 2020, the World Health Organization declared the Corona Virus Disease (Covid 19) as a pandemic due to the rapid increase of cases of infection throughout the entire world;

**WHEREAS**, it was declared in Presidential Proclamation No. 929, Series of 2020 that the entire country is placed in a State of Calamity for a period of six (6) months, unless lifted or extended as circumstances may warrant;

**WHEREAS**, the Department of the Interior and Local Government (DILG) issued Memorandum Circular No. 2020-062 subject of which is the Suppletory LGU Guidelines on the Implementation of Enhanced Community Quarantine in Luzon, and State of Public Health Emergency in Other Parts of the Country Due to the Covid 19 Threat;

**WHEREAS**, DILG MC No. 2020-062 directs all Local Government Units (LGUs) to fully implement the directives of the Office of the President for the Enhanced Community Quarantine for the Island of Luzon, and the State of Public Health Emergency for the rest of the country;

**WHEREAS**, the Sangguniang Bayan of Narvacan, Ilocos Sur, in its battle to prevent Covid 19, passed and approved Ordinance No. 19, Series of 2020 entitled An Ordinance Imposing Wearing of Mask or Any Protective Covering in Substitute of Mask and Curfew to Prevent Further Infections of the Novel Corona Virus Disease (Covid 19);

**NOW THEREFORE**, be it ordained by the Sangguniang Bayan of the Municipality of Narvacan, Ilocos Sur that:

**SECTION 1.** Section 2 of Ordinance No. 19, Series of 2020 shall be read as : The curfew shall be in effect for twenty four

(24) hours of the day pursuant to the general intent of the Enhanced Community Quarantine. Movement shall be regulated through the issuance of gate passes to designated individuals per household. Further, such movement shall be limited to accessing basic necessities, and provision for food and essential health services.

**SECTION 2. SEPARABILITY CLAUSE.** Should any provision, section or part of this Ordinance be declared invalid by any Court of competent jurisdiction, such judgment shall not affect or impair the remaining provisions, sections or parts hereof which shall continue to be in full force and effect.

**SECTION 3. REPEALING CLAUSE.** All Ordinances, rules and regulations or any part thereof found in conflict or inconsistent with any provision of this Ordinance are hereby repealed or modified accordingly.

**SECTION 4. EFFECTIVITY.** This Ordinance shall take effect immediately upon approval.

**AN ORDINANCE IMPOSING TOTAL LIQUOR BAN IN THE MUNICIPALITY OF NARVACAN, ILOCOS SUR DURING THE ENHANCED COMMUNITY QUARANTINE DUE TO COVID 19**

**WHEREAS**, on March 17, 2020, Pres. Rodrigo Roa Duterte declared the entire Luzon under Enhanced Community Quarantine in response to the growing pandemic of Covid 19 in the country;

**WHEREAS**, the Enhanced Community Quarantine is an expanded version of community quarantine which mandates strict home confinement, suspension of transportation lines, regulation of provision for food and essential health services and heightened presence of uniformed personnel to enforce isolation procedures;

**WHEREAS**, the Enhanced Community Quarantine prohibits mass gatherings to contain the spread of the Covid 19 virus;

**WHEREAS**, the Sangguniang Bayan of Narvacan deems it crucial to impose total liquor ban as another measure to contain the outbreak of Covid 19;

**NOW THEREFORE**, be it ordained by the Sangguniang Bayan of Narvacan, in session duly assembled that:

**SECTION 1.** A total liquor ban is hereby imposed effective March 23, 2020 until April 12, 2020 or until the implementation of the Enhanced Community Quarantine is lifted;


**SECTION 2.** Any person who shall take, sell, furnish, offer, buy, serve or drink intoxicating liquor shall be fined with:



**SECTION 3. ENFORCEMENT.** The Philippine National Police is hereby directed to implement this Ordinance and in consequence thereto, confiscate any contraband and file appropriate legal action. The Barangay Health Emergency Response Teams (BHERTs) are likewise mandated to implement the same in their respective barangays and in coordination with law enforcing agencies.

**SECTION 4. SEPARABILITY CLAUSE.** If for any reason, any provision, section or part of this Ordinance is declared invalid by a Court of competent jurisdiction, such judgment shall not affect or impair the remaining provisions, sections, or parts thereof which shall remain or continue to be in full force and effect.

**SECTION 5. REPEALING CLAUSE.** All ordinances, rules and regulations, or parts thereof, in conflict with or inconsistent with any provision of this Ordinance are hereby repealed, amended or modified accordingly.

**SECTION 6. EFFECTIVITY.** This Ordinance shall take effect immediately upon approval by the Sangguniang Bayan and Local Chief Executive of Narvacan.
