ORDINANCE NO. 19

Series of 2020

AN ORDINANCE IMPOSING WEARING OF MASK OR ANY PROTECTIVE COVERING IN SUBSTITUTE OF MASK AND CURFEW TO PREVENT FURTHER INFECTIONS OF THE NOVEL CORONA VIRUS DISEASE (COVID 19)

SECTION 1. This Ordinance shall cover all persons within the territorial jurisdiction of Narvacan, Ilocos Sur.

SECTION 2. The curfew shall be from 8:00PM to 4:00 in the following morning, starting from March 16 to April 16, 2020, unless the emergency situation shall be extended by the Government. All persons in the Municipality are prohibited from roaming around and loitering in all public places during the said hours.

SECTION 3. Exemptions:

- Those who work at night such as call center agents, hospital personnel such as doctor, nurses, and other health personnel, ambulance drivers, security guards, and those who may be allowed by the Task Force herein created;
- Delivery of basic necessities like food, medicines and gas stations (open for 24 hrs);
- Public transport services (buses, jeepneys, tricycles and the like) as determined by the Narvacan Traffic Management Office;
- Peace and Order Personnel in both municipality and barangay levels as determined by the Local Chief Executive;
- Emergency cases as determined by the Traffic Management Office of this municipality.

SECTION 4. All persons in the Municipality are hereby required to wear mask or any protective covering in substitute of mask when going outside their homes starting from March 16 to April 16, 2020, unless the emergency situation shall be extended by the Government.

SECTION 5. Penalty:

Those who SHALL violate this Ordinance shall be imposed with a penalty of paying a fine of:

- P 1,000 for the first offense
- P 2,000 for the second offense
- P 2,500 or one-month imprisonment or both at the discretion of the Court for the third offense

SECTION 6. Effectivity Clause – This Ordinance shall take effect immediately.
