AN ORDINANCE AUTHORIZING THE HONORABLE MAYOR LUIS "CHAVIT" SINGSON TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF NARVACAN, ILOCOS SUR, ANY AND ALL CONTRACTS, PAPERS, DOCUMENTS AND COMMUNICATIONS RELATIVE TO THE ACQUISITION AND/OR PURCHASE OF A PARCEL OF LAND COVERED BY TCT NO. T- 31735 OF THE REGISTER OF DEEDS OF ILOCOS SUR IN THE NAME OF WESTERN TEXTILE MILLS, INC. LOCATED AT NARVACAN, ILOCOS SUR

WHEREAS, by virtue of Resolution No. 25-SS, Series of 2019, the Sangguniang Bayan of Narvacan had authorized the Honorable Mayor LUIS "CHAVIT" SINGSON to, among others things, negotiate for the acquisition and/or purchase of that parcel of land covered by TCT NO. T- 31735, in the name of the WESTERN TEXTILE MILLS, INC. for the public purpose of establishing a municipal government complex, including and not limited to the erection of a municipal building, to take the place of the present municipal building/center, which is presently situated in an extremely congested location which has not become conducive to easy access and the speedy transaction of day to day government activities, business and transactions with the different government offices and agencies now found in the said municipal building;

WHEREAS, it appears that Mayor LUIS "CHAVIT" SINGSON had succeeded in the negotiation and arriving at an agreement for the acquisition and/or purchase of the said property at an adequate amount from the owners thereof;

WHEREAS, there is now need to pass an Ordinance to authorize the Honorable Mayor LUIS "CHAVIT" SINGSON to represent the Municipal Government and sign in its behalf all contracts and documents needed for the foregoing purpose;
