AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 5, SERIES OF 2020 FOR THE REALIGNMENT OF FUNDS OF THE PROGRAMS, PROJECTS, AND ACTIVITIES OF THE 20% DEVELOPMENT FUND FOR CY 2020 ENDORSED BY THE MUNICIPAL DEVELOPMENT COUNCIL-EXECUTIVE COMMITTEE

**BE IT ENACTED** by the Sangguniang Bayan of Narvacan, Ilocos Sur that:

**Section 1.** The Supplemental Budget No. 5 of the Municipality of Narvacan, Ilocos Sur for Fiscal Year 2020 in the total amount of One Million Five Hundred Thousand Pesos (Php 1,500,000.00) from the programs, projects, and activities of the 20% Development Fund for CY 2020 for the realignment of Construction/Rehabilitation of Public Market/Slaughterhouse/Mall is hereby approved.
