ORDINANCE NO. 34

Series of 2020

AN ORDINANCE PROVIDING GUIDELINES FOR APORS, LSIS AND ROFS OF NARVACAN DURING THE IMPOSITION OF LOW-RISK MODIFIED GENERAL COMMUNITY QUARANTINE IN ILOCOS SUR, AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF

WHEREAS, on June 22, 2020, through Resolution No. 48, Series of 2020, the Inter-Agency Task Force for the Management of Infectious Diseases (IATF) approved the recalibration of the parameters for risk classification of provinces, highly urbanized cities and independent component cities effective July 1, 2020;

WHEREAS, under the new IATF classification, areas with high risk of corona virus infection are either placed under Enhanced Community Quarantine (ECQ) or Modified Enhanced Community Quarantine (MECQ). Moderate risk places are classified under General Community Quarantine (GCQ) or Modified General Community Quarantine (MGCQ). Low risk areas fall under Modified General Community Quarantine (MGCQ);

WHEREAS, except for Cebu City and Talisay City that are under ECQ and MECQ respectively due to sharp rise in infection cases, the country is placed under GCQ or MGCQ until July 15, 2020 unless earlier lifted or further extended;

WHEREAS, despite the interventions and implementation of measures, the threat of Covid-19 remains high and alarming;

WHEREAS, the surge in the number of cases is caused by the return of people from Metro Manila areas, Luzon and other areas where positive cases of Covid-19 were already recorded and the return of OFWs from countries with confirmed Covid-19 cases;

WHEREAS, there is a need to build on the existing measures of the municipality relative to the Covid-19 outbreak and complement efforts to strengthen the implementation of said measures in order to protect the people of Narvacan from the contagion;

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of Narvacan, Ilocos Sur in session duly assembled that:

SECTION 1. This Ordinance shall be known as "An Ordinance Providing Guidelines for APORs, LSIs and ROFs During the Imposition of Low-Risk Modified General Community Quarantine in Ilocos Sur and Prescribing Penalties for Violations Thereof";

SECTION 2. Definition of Terms. As used in this Ordinance, the following shall be defined as:

Modified General Community Quarantine (MGCQ) – refers to the transition phase between General Community Quarantine (GCQ) and New Normal, when these temporary measures are relaxed: limiting movement and transportation, the regulation of operating industries, and the presence of uniformed personnel to enforce community quarantine protocols become less necessary.

Authorized Persons Outside Residence (APORs) – refer to those who are listed as exempted from the quarantine by the Inter-Agency Task Force on Emerging Infectious Diseases (IATF) such as those who render and deliver basic services, daily essentials, essential goods, utilities and other authorized persons. These include those going to work, delivery riders, health workers, authorized government officials and employees, transport sector, and public transport services.

Locally Stranded Individuals (LSIs) – refer to residents of Narvacan who are stranded in other localities and who have expressed their intention to return to their place of residence/home origin. These include students, workers, tourists, or any individuals who got stranded in a place.

Returning Overseas Filipinos (ROFs) – refer to residents of Narvacan who are returning to the Philippines from abroad. They may be categorized as:

Overseas Filipino Workers (OFWs) — refer to overseas Filipinos whose primary reason for being outside the country or for leaving the country is due to a contract of employment in a foreign nation or a vessel flying another nation's flag.

Non - Overseas Filipino Workers (non-OFWs) – refer to overseas Filipinos whose primary reason for being outside the country is not due to a contract of employment in a foreign nation or a vessel flying another nation's flag. These include returning students, J1 visa holders/exchange visitor's program,

returning Filipino diplomats, returning Filipino tourists, participants of Philippine government sponsored programs (trainings, scholarships), and dependents and accompanying foreign spouses.

SECTION 3. Authorized Persons Outside Residence (APORs), Locally Stranded Individuals (LSIs), and Returning Overseas Filipinos (ROFs) shall be allowed to enter the Municipality of Narvacan subject to the following conditions:

- 3.1. Authorized Persons Outside Residence (APORs). APORs must comply with all recent and applicable government issuances, with proper coordination with the Municipal Health Office. It is mandatory for the employers of APORs to set-up barracks for them to lodge in after work. APORs, whenever they go out for work, shall bring with them and comply with the following:
 - 3.1.1. Valid ID with proof of residence.
 - 3.1.2. Mandatory 14-day home quarantine if an APOR is out of the municipality for more than 24 hours. Prior to this, he/ she must have a Certification from the Barangay Captain that he/she has ready isolation area/room and separate comfort room at home.

During home quarantine, an APOR shall be regularly monitored by the Municipal Health Office and the Barangay Health Emergency Response Team (BHERT). He/She shall be guarded by a barangay official and tanod.

- 3.2. Locally-Stranded Individuals (LSIs). Prior to arrival, the LSIs must comply with all recent and applicable government issuances, with proper coordination with the Municipal Health Office. Upon scheduled arrival in the Municipality of Narvacan, LSIs are required to immediately proceed to the Municipal Rural Health Unit I to undergo Health Check prior to the mandatory 14-day home quarantine. LSIs must comply with the following procedures:
 - 3.2.1. Travel Authority from the Point-of-Origin
 - 3.2.2. Medical Certificate issued by the Health Officer of the Point-of-Origin

- 3.2.3. Valid ID with proof of residence
- 3.2.4. Certification from the Barangay Captain that he/she has ready isolation area/room and separate comfort room at home.

During home quarantine, LSI shall be regularly monitored by the Municipal Health Office and the Barangay Health Emergency Response Team (BHERT). He/She shall be guarded by a barangay official and tanod.

- 3.3. Returning Overseas Filipinos (ROFs). Prior to arrival, the ROFs must comply with all recent and applicable government issuances, with proper coordination with the Municipal Health Office. Upon scheduled arrival in the Municipality of Narvacan, ROFs are required to immediately proceed to the Municipal Rural Health Unit I to undergo Health Check prior to the mandatory 14-day home quarantine. ROFs must comply with the following procedures:
 - 3.3.1. Travel Authority (unless transported by OWWA/DOTr or any government agency)
 - 3.3.2. Certificate of 14-day quarantine completion
 - 3.3.3. Negative Real Time-Polymerase Chain Reaction (RT-PCR) test result
 - 3.3.4. Valid ID with proof of residence
 - 3.3.5. Duly accomplished Health Declaration Form at the Border
 - 3.3.6. Certification from the Barangay Captain that returning he/she has ready isolation area/room and separate comfort room at home.

During home quarantine, ROF shall be regularly monitored by the Municipal Health Office and the Barangay Health Emergency Response Team (BHERT). He/She shall be guarded by a barangay official and tanod.

SECTION 4. APORs, LSIs, and ROFs under home quarantine shall be required to have their own thermometer for temperature monitoring. They shall also be mandated to post at their home gates/doors this signage: "HOME ISOLATION"

SECTION 5. PENALTIES. Any person caught violating the provisions of Section 3 and Section 4 of this Ordinance shall be penalized.

- 4.1. Employers of APORs who shall not provide barracks for their APOR workers shall be penalized with: suspension or revocation of business permit.
- 4.2. APORs, LSIs, and ROFs found violating this Ordinance shall be meted with fines:

First Offense

- Php 1,500.00

Second Offense

- Php 2,000.00

Third Offense

- Php 2,500.00 or imprisonment of one (1) month or both at the discretion of the Court

If the offender is a public officer, the maximum penalty herein shall be imposed.

If the offender is a government employee, he/she shall be subject to disciplinary action.

SECTION 6. SEPARABILITY CLAUSE. If, for any reason or reasons, any part or provision of this Ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby, shall continue to be in full force and effect.

SECTION 7. REPEALING CLAUSE. All ordinances, rules or regulations in conflict with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 8. Upon urgent certification of the Mayor and motion unanimously approved suspending the rule on the 3-day reading of Ordinances, this Ordinance shall be effective immediately upon approval.

SECTION 9. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately upon its approval.
