ORDINANCE NO. 33
Series of 2020

AN ORDINANCE RENAMING NANGUNEG WEST PRIMARY SCHOOL TO NANGUNEG WEST ELEMENTARY SCHOOL

WHEREAS, under Section 13 (c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the members of the Sanggunian are vested with the power to change or rename a public school upon recommendation by the Local School Board concerned within its territorial jurisdiction;

WHEREAS, the Local School Board thru Resolution No. 2-LCS endorsed and recommended to this Sangguniang Bayan the renaming of Nanguneg West Primary School to Nanguneg West Elementary School;

WHEREAS, after careful evaluation, this Sanggunian finds the recommendation of the Local School Board to be of merit;

NOW THEREFORE, on motion duly seconded, **BE IT ORDAINED** by the Sangguniang Bayan of Narvacan that:

SECTION 1. NAME. The name of Nanguneg West Primary School located at Nanguneg West, Narvacan, Ilocos Sur is hereby renamed and shall hereafter be referred to as Nanguneg West Elementary School.

SECTION 2. SEPARABILITY CLAUSE. If any portion or provision of this Ordinance is declared invalid, the same shall not affect the validity and effectivity of the other provisions not affected thereby.

SECTION 3. APPROVAL. Upon urgent certification of the Municipal Mayor and motion unanimously approved suspending the rules on the 3-day readings of Ordinances, this Ordinance shall be adopted immediately upon approval. Upon approval, copies of this Ordinance shall be furnished to the Department of Education, the Local School Board and all parties concerned for their information and guidance.

SECTION 4. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.
