ORDINANCE NO. 31

Series of 2020

ORDINANCE EXTENDING THE DEADLINE FOR THE PAYMENT OF TAXES ON BUSINESSES PAYING ON A QUARTERLY BASIS WITHOUT INTERESTS AND SURCHARGES, THE RENEWAL OF TRICYCLE FRANCHISE COVERING MARCH 16-APRIL 30, 2020 WITHOUT PENALTIES, AND FURTHER WAIVING THE PAYMENT OF STALL RENTALS AT THE NARVACAN PUBLIC MARKET AND NARVACAN MALL, ALL UP TO MAY 31, 2020

WHEREAS, Section 167 of Republic Act 7160, the Local Government Code provides that the Sanggunian, for a justifiable reason or cause, may extend the time of payment of such taxes, fees or charges without penalties, surcharges and interest, but only for a period not exceeding six (6) months;

WHEREAS, Presidential Proclamation No. 922, Series 2020, dated March 8, 2020 declared the entire country under a State of Public Health Emergency;

WHEREAS, Presidential Proclamation No. 929, Series of 2020, dated March 16, 2020 placed the entire country under a State of Calamity for a period of six (6) months;

WHEREAS, on March 15, 2020, the Honorable Ryan Luis V. Singson, Governor of the Province of Ilocos Sur, issued Executive Order No. 14, placing the entire Province of Ilocos Sur, under Enhanced Community Quarantine;

WHEREAS, the town of Narvacan was under a State of Enhanced Community Quarantine prohibiting residents from going out of their homes, and suspending regular government transactions and operation of certain businesses due to the COVID-19 Pandemic;

WHEREAS, due to the foregoing, the payment of stall rentals at the Narvacan Public Market and Narvacan Mall was previously waived for the period from March 15 to April 30, 2020;

WHEREAS, the reasons for the said extension still exist and there is therefore a need for the extension of the same;

NOW THEREFORE, upon motion waiving the three (3) readings of ordinances which is compelled by the current situation, and upon unanimous vote, BE IT ORDAINED:

SECTION 1. EXTENSIONS:

- 1. The period of payment of taxes on businesses paying on a quarterly basis which should have been due on or before March 31, 2020 is hereby EXTENDED, and the same should be paid not later than May 31, 2020 without penalties, surcharges and interests, provided they are paid within the said extended period;
- 2. The renewal of tricycle franchise covering March 16-April 30, 2020 is hereby EXTENDED, and the same should be renewed not later than May 31, 2020 without penalties, provided they are paid within the said extended period;
- The waiver of payment of stall rentals at the Narvacan Public Market and Narvacan Mall is likewise further extended to May 31, 2020.

SECTION 2. EFFECTIVITY — Due to the present medical emergency and the situation of the entire country and upon motion duly approved suspending the rules of the 3-day reading for the passage of an Ordinance, this Ordinance shall take effect immediately upon its approval.

Let copies of this Ordinance be posted in prominent places in the municipal hall and publication be made when conditions will warrant.
