ORDINANCE AMENDING ORDINANCE NO. 24, SERIES OF 2020 "ENACTING THE NARVACAN ANTI-COVID-19 ORDINANCE"

WHEREAS, the Sanggunian Bayan had previously enacted Ordinance No. 24, Series of 2020 entitled "ENACTING THE NARVACAN ANTI-COVID-19 (NOVEL CORONA VIRUS) ORDINANCE, CONSOLIDATING ALL ANTI-CORONA ORDINANCES, MEASURES AND ISSUANCES, AND FOR OTHER PURPOSES";

WHEREAS, there is a need to further involve, motivate help and support the efforts of the basic local government units, specifically the Barangays in the struggle against the Covid-19 pandemic;

WHEREAS, Sec. 15 of Ordinance No. 24, Series of 2020, has a penal clause providing for penalties for violations thereof;

WHEREAS, there is need to amend the said Ordinance, particularly the penal clause thereof to make it more responsive to the special needs of the present crisis on the Barangay level;

NOW THEREFORE, on motion duly seconded, be it ordained by the Sanggunian Bayan of Narvacan, Ilocos Sur:

That SECTION 15, Penal Clause of Ordinance No. 24, Series
 2020 of the Municipality of Narvacan, Ilocos Sur shall read as follows:

Unless the acts committed may also be punished under Republic Act 11332, the Revised Penal Code, particularly Art. 15, 172, 173 thereof, and by other relevant provisions and statutes, violators of any of the provisions of Sections 4, 5, 6, 8, 9, 10, 11, 12 and 13 of this Ordinance shall be charged and if found guilty by the Court of proper jurisdiction, shall suffer the following penalties:

- a. Fine of P1,000.00 for the FIRST OFFENSE
- b. Fine of P2,000.00 for the SECOND OFFENSE
- c. Fine of P2,500.00 and/or imprisonment of not more than SIX
 (6) MONTHS, or both fine and imprisonment at the discretion of the Court, for the THIRD AND SUBSEQUENT VIOLATIONS thereafter committed.

Provided that, In the event that the violator/s should be APPREHENDED AND/ OR ARRESTED BY BARANGAY AUTHORITIES

OR THEIR DEPUTIES, ONE HALF (50%) of the fine imposed on said violators as stated above, shall pertain to and be released by the Municipal Treasurer to form part of the General Fund of the Barangay concerned.

- SECTION 17. SEPARABILITY CLAUSE. Should any provision, section or part of this Ordinance be declared invalid by any Court of competent jurisdiction, or by the Sanggunian Panlalawigan upon review, the same shall not affect or impair the remaining parts thereof and they shall continue to be in full force and effect.
- That SECTION 18. ENACTMENT AND PERIOD OF EFFECTIVITY shall read as follows:
 - That due to the critical national emergency posed by the COVID-19 pandemic, and upon urgent certification by the Municipal Mayor and also on motion unanimously approved suspending the rules on 3 day reading of ordinances, which is compelled by the current emergency, in order not to defeat its purpose and to effectively and immediately fulfill its objectives, this Amendatory Ordinance shall be effective immediately upon approval;
 - Publication of this Amendatory Ordinance pursuant to law shall be made, when feasible, and without affecting its immediate validity and implementation, and a copy of the same shall also be furnished the Chief Executive Officer of the Official Gazette; provided that, copies of this Amendatory Ordinance shall however be POSTED at prominent places in the municipal hall.
 - 3. The Secretariat of the Sanggunian Bayan is also hereby mandated to furnish copies of this Amendatory Ordinance to the DOH, RHU, PNP, AFP, Judge of the RTC and MTC, Prosecutors, PAO, DSWD, DILG, BARANGAY CAPTAINS, and all interested sectors, stakeholders, parties and those who may wish to obtain a copy of the same.
 - 4. Unless otherwise mandated by any national legislation or an amendatory or repealing Ordinance, this Ordinance shall remain in force and effect, until September 16, 2020 which is the period of the State of Calamity imposed throughout the Philippines by Proclamation No. 292, issued by the President of the Philippines on March 16, 2020.
