AN ORDINANCE AUTHORIZING THE REALIGNMENT OF THE ANNUAL BUDGET FY 2020 THROUGH SUPPLEMENTAL BUDGET NO. 01 TO ADDRESS THE CURRENT COVID-19 CRISIS

SECTION 1. The Supplemental Budget No. 01 of the Local Government Unit of Narvacan for Fiscal Year 2020 in the total amount of Eighteen Million Pesos (P 18,000,000.00) to address the current Covid-19 crisis and preparing for its unforeseeable effect is hereby approved.
