ORDINANCE NO. 64 Series of 2020

AN ORDINANCE CREATING A NARVACAN CONTRACT TERMINATION REVIEW COMMITTEE (CTRC) AND PRESCRIBING THE COMPOSITION THEREOF AND FOR SUCH OTHER RELEVANT PURPOSES

WHEREAS, in a communication from the Office of the Municipal Mayor dated November 19, 2020, the attention of the Sangguniang Bayan was called to the cases of certain infrastructure projects entered into by the municipality and contractors whereby the contractors have failed to comply with the provisions of their contracts;

WHEREAS, in the said communication, the Office of the Mayor cited the guidelines set by the Government Procurement Policy Board (GPPB) relative to manner with which to deal with public infrastructure projects in the event of the default of the contractors;

WHEREAS, in order to deal with the matter, the Office of the Mayor has suggested the creation by the Sanggunian Bayan of a CONTRACT TERMINATION REVIEW COMMITTEE (CTRC) in order to review and study defaulting projects and contracts so that pursuant to the guidelines of the GPPB the Office of the Mayor can proceed with the termination of contracts and impose liquidated damages and/or the institution of actions for civil damages or such other courses of action and remedies that may be adequate and necessary under certain circumstances;

NOW THEREFORE, on motion duly seconded, **BE IT ENACTED**:

SECTION 1. That a **CONTRACT TERMINATION REVIEW COMMITTEE (CTRC)** is hereby created to review the status of public infrastructure projects entered into by the municipality, the degree of compliance with the terms thereof, the violations or default on the term as of the contracts, if any, and to recommend the courses of action under each given situation such as termination of the contract, liquidated damages, forfeiture, civil action in court and such other remedies as may be warranted by the attending circumstances;

SECTION 2. For this purpose a CONTRACT TERMINATION REVIEW COMMITTEE (CTRC) is hereby created to be composed of the following:

- a. a representative of the Office of the Municipal Mayor
- The Municipal Vice Mayor or his duly authorized representative
- c. Two (2) members of the Sangguniang Bayan, chosen by the members thereof
- d. The Municipal Accountant or his duly authorized representative
- e. The Municipal Treasurer or his duly authorized representative

SECTION 4. Repealing Clause. All ordinances and administrative circulars and executive orders, or parts thereof that are found to be inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 5. Effectivity Clause. On motion unanimously approved suspending the rule on the 3-day reading of Ordinances, this Ordinance shall take effect immediately upon its approval.
