ORDINANCE NO. 63
Series of 2020

AN ORDINANCE GRANTING 100% MORATORIUM ON THE COLLECTION OF PARKING FEE AND GARBAGE FEE FOR THE WHOLE YEAR OF 2021 OF ALL REGISTERED MEMBERS OF THE NARVACAN TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (NATODA)

WHEREAS, submitted to the Sangguniang Bayan for its consideration and approval is the request of the Narvacan Tricycle Operators and Drivers Association (NATODA) that its registered members be granted 100% moratorium on the collection of their parking fee and garbage fee for the whole year of 2021;

WHEREAS, such appeal was made after their operation was adversely affected due to the implementation of community quarantines brought about by the Covid-19 pandemic;

WHEREAS, the Legislative Body acknowledges the lack of income of the tricycle operators and drivers during the community quarantines, thus hampering their capacity to pay fees and charges;

WHEREAS, to ease the burden of the tricycle operators and drivers of this Municipality during the times of community quarantine, it is but proper to provide them relief so as to reserve their finances on procurement of basic goods and other necessities;

NOW THEREFORE, in session duly assembled, **BE IT ENACTED BY THE SANGGUNIANG BAYAN OF NARVACAN, ILOCOS SUR** that:

SECTION 1. A 100% moratorium on the collection of Parking Fee and Garbage Fee is hereby granted to all registered members of the Narvacan Tricycle Operators and Drivers Association (NATODA) for the whole year 2021. However, payment of Sticker and Secretary's Fee shall be collected.

SECTION 2. This Ordinance shall apply only to registered Members of the NATODA. It does not cover tricycle operators and drivers who are residents of other municipalities but with franchises to operate within the territorial jurisdiction of this Municipality.

SECTION 3. Separability Clause. If for any reason, any part or provision of this Ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected shall continue to be in full force and effect.

SECTION 4. Repealing Clause. All ordinances and administrative circulars and executive orders, or parts thereof that are found to be inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 5. Effectivity Clause. On motion unanimously approved suspending the rule on the 3-day reading of Ordinances, this Ordinance shall take effect immediately upon its approval.
