AN ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF THE MUNICIPALITY OF NARVACAN IN THE AMOUNT OF ONE HUNDRED FIFTY MILLION PESOS (P 150,000,000.00) TO FUND THE ACQUISITION OF LOT FOR DEVELOPMENT PROJECTS

BE IT ENACTED, as it is hereby ENACTED, by the Sangguniang Bayan of Narvacan, Ilocos Sur, in session assembled that:

SECTION 1. The Municipal Mayor, in representation of the Municipality, hereinafter referred to as the Municipality of Narvacan, is hereby authorized to enter into a Loan Agreement with Landbank of Philippines in accordance with Section 297 of Republic Act No. 7160 or the Local Government Code, in the amount of One Hundred Fifty Million Pesos (P 150,000,000.00) under the terms and conditions herein set forth and such other terms and conditions as may be agreed upon with any person, corporation or entity for the purpose of funding priority project/s, and subject to the requirements under Section 123 of Republic Act No. 7653 as implemented by the Bangko Sentral ng Pilipinas Circular No. 402. In this connection, the Municipal Mayor shall have full power and authority to represent the Municipality in negotiating the terms and conditions for the said borrowing and in signing, executing and delivering such agreements, contracts, deeds, papers, and documents as may be necessary and proper for the full and total implementation of the authority herein granted.

SECTION 2. The said priority project/s herein specified as the Acquisition of Lot is hereby certified to be a socio-economic development projects in accordance with the approved local development plan and public investment program for the period 2020 to 2021 of the Municipality of Narvacan.

SECTION 3. Consistent with the covering Loan Agreement/Contract, deeds and assignment, mortgage contracts, and such other agreements as maybe entered into by the municipality in connection with the borrowing, the features, terms and conditions shall be as follows and are hereby approved.

3.1 PROJECT NAME—Acquisition of Lot Property

- Borrower—Municipality of Narvacan, Ilocos Sur
- Amount—Php 150,000,000.00
- Purpose—To finance the acquisition of lot property
- Term/Tenor—10 years

Manner of Payment:

- Interest—Payable monthly in arrears to start at the end of the 1st month from date of loan release
- Principal—Payable in 120 equal monthly payments to start at the end of the 1st month from date of loan release
- Interest Rate—At prevailing rate of LANDBANK at the time of availment, subject to annual repricing
- Collateral/Guarantee/Security— The loan shall be secured by Assignment of 20% of total Internal Revenue Allotment.
- Front-End Fee-N/A
- Commitment Fee-Waived
- Guarantor-N/A
- Guarantee Fee—N/A
- Sinking Fund (if applicable) or other Funding Arrangements—N/A

SECTION 4. The municipality hereby appropriates the entire proceeds of the borrowing exclusively to finance the Acquisition of Lot Property and other financial obligations relative thereto.

SECTION 5. Any Ordinance or parts thereof, inconsistent with this enactment is hereby repealed or amended accordingly.
