ORDINANCE NO. 51

Series of 2020

AN ORDINANCE ESTABLISHING THE "NARVACAN FISHERIES AND AQUATIC DEVELOPMENT EDUCATION SUPPORT PROGRAM" AND APPROPRIATING FUNDS THEREFOR

WHEREAS, in pursuant to the 1987 Philippine Constitution, the State shall protect and promote the right of all citizens to quality at all levels and shall take appropriate steps to make such education accessible to all and shall maintain and support a complete, adequate, and integrated system of education relevant to the needs of the people and society;

WHEREAS, in pursuant to the 1987 Philippine Constitution, the State shall establish and maintain a system of scholarship grants, student loan programs, subsidies, and other incentives which shall be available to deserving students in both public and private schools, especially to the underprivileged;

WHEREAS, the Ilocos Sur Polytechnic State College (ISPSC) - Narvacan, known as the Narvacan School of Fisheries was established in 1964 by virtue of Republic Act No. 3476, entitled "An Act providing for the Establishment of a School of Fisheries in the Municipality of Narvacan, Province of Ilocos Sur, and Authorizing the Appropriation of Funds Therefor", which was authored by Cong. Pablo C. Sanidad, which was signed into law on June 16, 1962;

WHEREAS, by virtue of Sangguniang Panlalawigan Resolution No. XVII-126PR (Series of 2017), the Province of Ilocos Sur declared the Narvacan School of Fisheries—ISPSC as the Center of Fisheries and Aquatic Development of the Province of Ilocos Sur and remains to be the primary tertiary educational institution in the Municipality of Narvacan, Ilocos Sur;

WHEREAS, by virtue of the Executive Order No. 22—LCS, dated September 21, 2020, the Municipal Mayor, Hon. Luis "Chavit" C. Singson, established the "Narvacan Fisheries & Aquatic Development Education Support Program" of the Municipality of Narvacan, Ilocos Sur;

WHEREAS, in order to aid in the growth of Fisheries and Aquatic Development Education not only in the Municipality of Narvacan but also in the entire Province of Ilocos Sur, the Municipal Government seeks to formalize the establishment of the "Narvacan Fisheries & Aquatic Development Education Support Program" to provide educational assistance to deserving students, especially to the underprivileged;

Be it Ordained by the Sangguniang Bayan of the Municipality of Narvacan, Ilocos Sur, that:

SECTION 1. TITLE. This Ordinance shall be known as the "Narvacan Fisheries & Aquatic Development Education Support Program Ordinance" of the Municipality of Narvacan, Ilocos Sur.

SECTION 2. CREATION. The Sangguniang Bayan of the Municipality of Narvacan, Ilocos Sur hereby create the "Narvacan Fisheries & Aquatic Development Education Support Program" for deserving students, especially the underprivileged, who enroll in Fisheries & Aquatic Development Education Courses offered within the territorial jurisdiction of the Municipality of

SECTION 3. OBJECTIVES. The objectives of the "Narvacan Fisheries & Aquatic Development Education Support Program" shall be to:

- a. Promote Fisheries & Aquatic Development Education in the Province of Ilocos Sur;
- Provide Educational Assistance to deserving students, especially the underprivileged who enroll in Fisheries & Aquatic Development Courses:
- c. Promote the growth and maintenance of the Narvacan School of Fisheries as the primary tertiary educational institution in the Municipality of Narvacan, Ilocos Sur and the Center of Fisheries and Aquatic Development of the Province of Ilocos Sur.

SECTION 4. EDUCATIONAL SUPPORT PROGRAM. The "Narvacan Fisheries & Aquatic Development Education Support Program" shall involve the following:

- Enrollment Incentive: One Thousand Pesos (Php 1,000.00)
 Enrollment Incentive to incoming First Year students who enroll in Fisheries & Aquatic Development Courses;
- Cash Assistance: Three Thousand Pesos (Php 3,000.00) per semester to enrollees of Fisheries & Aquatic Development Courses (regardless of year level);

SECTION 5. QUALIFICATIONS. To avail of the Program, applicants must possess the following qualifications:

- a. Must be a Highschool Graduate
- b. Passed—Initial Program Assessment Interview

SECTION 6. DOCUMENTARY REQUIREMENTS. Applicants must submit the following documentary requirements:

For incoming First Year Students:

- a. Letter of Intent to avail of the Program;
- b. Duly accomplished "Narvacan Fisheries & Aquatic Development Education Support Program" application form;
- c. High School Diploma (photocopy);

Ordinance No. 51, Series of 2020 a. Determine other criteria and requirements for the application

- to the Program;
- b. Determine the eligibility of every applicant for the Program;
- c. Review and examine the requirements submitted by the applicants:
- d. Approve applications and determine the number of recipients of the program for every fiscal year;

SECTION 9. RELEASE OF GRANTS/INCENTIVES. The grant/incentive of every recipient of the Program shall be released through a payroll system attaching the recipients college assessment/enrollment for, issued by the School/University, along with the Certificate of Eligibility to the Program duly signed by the Chairman of the Education Support Council, as supporting papers thereof, subject to the usual Government Accounting and Auditing Procedures.

SECTION 10. FUNDING. The Program shall be funded under the existing budget item of "Scholarship Grants/Expenses" under the Office of the Municipal Mayor.

SECTION 11. SEPARABILITY. If any section or part of this Ordinance is held unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force and effect

SECTION 12. REPEALING CLAUSE. All other Ordinances, Issuances, Rules, and Regulations which are inconsistent with the provisions of this Ordinance are hereby repealed, amended, or modified accordingly.

SECTION 13. EFFECTIVITY. Upon Urgent Certification of the Mayor and on motion unanimously approved suspending the rule of the 3-day reading and calendar of the Ordinance, this Ordinance is effective immediately upon its approval.
