**AN ORDINANCE PROHIBITING KULIGLIGS AND TRACTORS TO TRAVEL
ALONG THE NATIONAL HIGHWAY WITHIN THE TERRITORIAL JURISDICTION
OF THE MUNICIPALITY**

BE IT ORDAINED by the Sangguniang Bayan duly assembled that:

Section 1. Regulated act. All kuligligns and tractors are prohibited to travel along the national highway within the territorial jurisdiction of the municipality to prevent vehicular accidents involving said vehicles which cause deaths, injuries and destruction to properties of the people in the community.

Section 2. Penal Clause. Any violation hereof shall be punished by:

First offense – A fine of Php 300.00

Second offense – A fine of Php 500.00

Third offense – A fine of Php 1,000.00 or imprisonment of not more than sixty (60) days, or both, at the discretion of the court.

Section 3. Enforcement. The Local Philippine National Police and the Local Traffic Enforcers are hereby mandated to apprehend violators of this Ordinance.

Section 4. Repealing clause. All municipal ordinances, executive orders, administrative regulations or parts thereof which are inconsistent to any of the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 5. Separability clause. If for any reason or reasons, any part of the provisions of this Ordinance shall be declared unconstitutional or invalid, other parts or provisions hereof which are not affected shall continue to be in force and effect.


Section 6. Effectivity clause. This Ordinance shall take effect upon its approval.






